

WHEN IS A "PAQUEBOT" COVER NOT A "PAQUEBOT" COVER.

The increasing interest in covers and postal history has produced a spate of attractive covers that are represented as rare examples of postal history. In some cases these "too good" covers are what they are claimed to be, but in other cases they come from very questionable parentage. The cover below was marked with the ticket stamp on the *S.S. PRINCE GEORGE* dated May 31, 1969, and then marked with a "PAQUEBOT" SKAGWAY hand stamp before being mailed at Skagway on June 1. 1969. The cover looks like a rare "paquebot" cover but this is not the case.



The cover in fact is one of 27 produced by Vern Ardiff, a well known collector of ship cancellations. Vern found that Skagway, Juneau, and Ketchikan, Alaska post offices did not have "paquebot" or "Way Mail" markings and solved the problem by having suitable markings produced. These hand stamps were not approved by the United States Post Office and appear to have been used only on "cancel to order" (CTO) items produced by Mr. Ardiff or other CTO producers. The question is, was the "paquebot" cancellation applied illegally by the Skagway post office or by Mr. Ardiff?

WHEN IS A "PAQUEBOT" COVER NOT A "PAQUEBOT" COVER continued.

Similar "paquebot" markings were produced for British Columbia ports, in 1979, by Eugene Peterson and, in 1980, by Gene Falada. Markings have been reported for Coquitlam, Crofton, Kitimat, Nanaimo, Prince Rupert, Squamish, Tahsis, Vancouver, and Victoria. Similar markings were also produced for Eastern Canadian, as well as, West Coast United States ports.



PRINCE RUPERT-PAQUEBOT 54° 22N - 130° 30W




There is much confusion as to the status of these questionable "paquebot" markings. Gustave J. Lund lists them in his 1984 publication <u>The Paquebot Marks</u> of the <u>Americas</u> while Roger Hosking, in the 1987 second edition of <u>Paquegot</u> <u>Cancellations of the World</u> does not include them. Collectors are equally divided. There are those who hold the ship covers produced by William C. Vestal, of Redlands, California, and other producers of ship covers, in very high regard while others despise the inclusion of these items in collections.

The same problem exists with the ship markings as listed in Lewis M. Ludlow's, <u>Catalogue of Canadian Railway Cancellations</u>. In general markings used as corner cards rather than as postal markings were not listed. The S.S. PRINCE GEORGE marking on the cover below is not listed in Ludlow because it was a corner card rather than a ship cancellation. The only justification for the marking was under UPU regulations to explain the use of Canadian stamps on mail sent outside Canada, namely Ketchikan, Alaska. The Ketchikan "paquebot" marking is one of those produced by Vern Ardiff and is of an even more questionable nature.



The pair of covers below are marked on the back "MS / 205" are purported to have been mailed on the *PRINCESS ELAINE* on June 4, 1954. At the time it was on the Nanaimo-Vancouver run and had no reason to accept or process mail and as a result the marking is not listed by Ludlow. The cover addressed to Frank M.Fish has been further embellished by the addition of a "PACABOT" marking applied after the cover was received. It looks good but ...




The World Ship Society and other similar organizations have produced many similar covers that are sold to unsuspecting collectors as extremely rare. The failure of catalogues to explain these markings, of a questionable nature, has prompted some dealers to place a high value on these "unlisted by ..." items and as a result covers that should sell for a few dollars are being listed in the hundred to five hundred dollar price range. These philatelic or CTO items are so common that it is impossible to list all of them but fledgling collectors should be aware of them and treat them for what they are, and not, as what some dealers would like them to be.

RC NUMBER - the origin and use

The introduction of the current "RC" numbers can be traced back to the assigning, in the early 1930's, of the four-digit accounting numbers that were used to identify post offices within Canada. The intials "RC" are used to identify the ten-digit "Responsibility Centre" numbers used for accounting purposes by Canada Post. At the same time a six, soon to be seven, digit portion of the number is used to identify the "Retail Counter" within each post office. These six-digit numbers are the numbers used on the standard rectangular daters used in most post offices.

The use of the "RC" number to identify the operator of a postal outlet while at the same time, in an expanded form, being used to identify accounting areas with the postal outlet has caused considerable confusion among postal historians. To further add to the confusion, un-listed "RC" numbers are also assigned to the various branches, depots or sections within some of the larger post offices. The three RC numbers found on the daters from Trail, B.C. are a good example of this problem. The official counter number for Trail is 647209 but the numbers 637823 and 051152 have been used to identify the Letter Carrier Depot and the Delivery Section within the Trail Post Office Building. To fully understand the present RC number system, it is necessary first to look back at the developemnt of the original "Office Numbers". These are the number referred to by collectors as Money Order Office Numbers, or "MOON's" for short.



Post offices in Canada were first assigned numbers in the mid 1930's. At first four-digit numbers were assigned to Accounting Post Offices and later five-digit numbers were assigned to Non-accounting Post Offices. These numbers were assigned to the post office name and indicated the status of the post office. If the status of an office was changed, the number was also changed. The first digit of the number was also used to identify the region in which the post office was located. For example all British Columbia Accounting Post Offices were assigned numbers in the 9000 series. From time to time other number series were assigned to identify special types of offices such as Postal Outlets.

In 1973, a new six-digit number series was introduced to solve the problem of a shortage of numbers in regions such as Ontario. Again the first digit of the number could be used to identify the region in which the post offices was located, and like the earlier series a number was assigned to the post office rather than the postmaster or operator. Larger offices such as Trail might be assigned more than one number for accounting purposes, but only the front counter number was listed in the official list of post offices. Thus although Trail, BC was officially assigned the number 647209, the number 637823 was also assigned to the Trail Letter Carrier Depot in the same building.


In the late 1980's, a major change in the post office accounting methods took place and a new ten-digit number system was introduced. The numbers were initially referred to as "HIRS" (Human Inventory Resource System) numbers and were assigned to the owner/operator of the Retail Counter rather than to the Post Office itself. The first seven digits identify the Retail Counter (RC), although at present all numbers appear as six-digit numbers with one or more unwritten zeros preceeding the number. Within the next few years, when the present series of six-digit numbers will be exhausted, the seven-digit numbers will come into use.

For post offices established prior to 1990, the six-digit number shown on the dater at the retail counter remained unchanged. For example the number shown on the Trail Post Office dater remained 647209 but the actual ten-digit number was 0647209010 with the last three digits "010" being used to indicate counter The last three digits "450", "490", and "570" were assigned for service. accounting purposes to identify different section or branches within the Trail Post Office such as the Letter Carrier Depot. At the same time Retail Managers and Retail Reps are assigned RC#'s with up to eight sub numbers being used to identify the various accounts under their jurisdiction. Occasionally these numbers are used on daters and the Trail RC# 051153 falls into this category. A study of the ten-digit numbers shows that it is possible to identify post office status using the last three digits of the ten-digit numbers. For example Semi-staff offices end in "470" while Retail Outlets end in "920" and Revenue Offices end in "480".

At the same time as the new numbers were introduced, the post office policy was changed and the new numbers were assigned to the operator of the retail counter rather than the actual post office name as was done in the past. As a result each time a retail counter (post office) changes ownership a new number is used. The new numbers were initially assigned as blocks of numbers to each region but this was quickly changed and, at present all numbers are assigned from Ottawa. Each of the new numbers contains a check digit, designed to reduce the chances of error in recording the numbers. (A more detailed study of the use of check digits can be found in the <u>PHSC Journal</u>, Vol. 59 page 15.) As a result of the use of a check digit is that about one in every eight consecutive number is assigned. The numbers, which are assigned consecutively, ignore postal regions but do give an indication as to the date when a request was made for a change in postal status.

From time to time, under the new accounting system introduced in 1990, numbers are assigned to special postal functions such as Commercial Sales and these numbers are used on daters much to the confusion of postal historians. The two numbers below are such numbers. The RC number 640026 was assigned to the Pacific Division Cash Accounts Section which was further divided, for accounting purposes, into 11 sub sections using the ten-digit number system. The 640018 RC number was used at the Vancouver Postage Stamp Depot and was withdrawn before 1995 when the B.C. and Yukon Postage Stamp Depot was moved to Edmonton.

These in-house numbers are extremely rare but do appear from time to time on regular mail. A complete listing of all the ten digit numbers for British Columbia would run to over 30 pages and would only further muddy an already confused situation.

POSTAL WATCH Bill Topping

On a recent trip to Vancouver Island I spent my spare time visiting recently established post offices and at each post office I obtained a cancellation from the rubber dater.

The first, and most obvious, fact was that although all the daters were manufactured in 1999, there was no consistency in shape or information shown on the daters despite the fact that almost all the offices were designated as FA (Franchise "A"). Samples of the variety of markings obtained are shown at right.

Although most of the new post offices had been issued with MI-00048 (96-09) labels some were issued the older pre 1996 types. A few office refused to provide labels but for the most part I found the postal clerks most co-operative and would like to express my thanks for their assistance.

At the same time a number of errors were noted.

Harbour Centre RO (355712) was using the new RC number on the label and receipt but was issued with a dater showing the former number 636053.


Gorge Plaza RO (355976) is an upgrade of the former Victoria SUB 61 and replaces the recently closed Tillicum RO located a few blocks away. The receipt shows the correct office name and RC number but the newly issued dater reads 355976 SUB/AUX 61 and the incorrect postal code V9V 1TO not V9A 2AO.


Lagoon Grocery (382930) and Bookkeeping Unlimited (382922) in Nanaimo are both parcel pick up (SC) locations and have no equipment showing the name or RC number of the office.

Willingdon Heights, which was moved a mile or so to the west, is shown as being in Vancouver in the postal records but the dater reads BURNABY, which is correct.

CANADA POST 2000

Collectors continue to complain about the number of products produced by Canada Post. Unfortunately the special products are not produced for the true collecter. Over a third of a million people maintain a deposit account with Canada Post Philatelic section and in most cases they purchase one or more copies of each issue released.

One of the latest promotions was the Millennium Collection. The Official Millennium Keepsakes stamp box, retailing at \$8.99 plus taxes, produced 1.2 million sales. At the same time 200,000 copies of the Millennium Collection stamps books, retailing at \$59.99 plus taxes, were printed. Although according to Michel Tremblay, vice-president of Retail Business, the sales target for both products were not met. At the same time to overcome the objections of catalogue publishers to stamps in the Millennium Stamp Book not being issued for postal purposes, Canada Post is producing 17 Millennium Souvenir Sheets, of four stamps each, featuring the stamps contained in the Stamp Book. The press run is expected to be 36 million sheets with some stamps being available in booklet form as well.

Add to these, the year 2000 Millennium coin sets, at \$24.95, plus taxes, or \$149.95 for sterling silver coins, is being successfully sold by Canada Post, and it is not surprising that Canada Post pays little regard to stamp collectors complaints regarding the number of products being produced by Canada Post.

The Santa letter-writing Program also produced a good return for Canada Post as over one million letters were received each with a 46 cent stamp affixed. In fairness to Canada Post it should be pointed out that 13,000 volunteers replied to 1,026,601 lettters received in 1999, an increase of four-percent from 1998.

Despite conserns that the internet and e-mail would put Canada Post out of business the use of Canada Post has increased in all areas. The revenue from letter mail is up by 2.2 percent, while the revenue from Xpresspost was up 27 percent. Revenue from both Addressed, Addmail and Regular Parcel Post were up slightly while Expedited Parcel Post increased by 29.3 percent.

A CHECKLIST OF BRITISH COLUMBIA POST OFFICES

The introduction of the Human Resource Inventory System (HRIS) numbers also referred to as "RC" (Responsibility Centre or Retail Counter) numbers and the change to assigning the RC number to the owner or operator of the Postal Outlet has produced many problems in the listing of current post offices. In the past, Checkists listed the post offices in alphabetical order with sub offices listed under the name of the main post office. In most cases the name were the name appearing on the metal dater and the rubber money order stamp. This system of listing is not suited to the dating equipment issued today. The basic daters contain the "RC" number, the name of the city or region, and the name of the province. In a few cases the Sub/GMO name or number may be included as well as the postal code. Only in a few cases does the rubber dater contain the actual name of the postal outlet. Duplication of Retail Outlet names is also common.

This months Reply Sheet asks for input as to what information should be included in an up date of the BC Checklist of Post Offices and how offices should be arranged. A complete listing of all Post Office in operation since 1990 takes about 30 pages. RESPONSE FORM
