Mike Dicketts send two items of interest from the E. Van Dam mail auction of last October. M9 MET/LIFE on FWT 8 (R230) sold for \$110. and M15 MLI/Co on FWT 12 (R234) realized \$75. The Metropolitan Life Perfin is very scarce and we can assume that the stamp has been transferred from a revenue collection to a perfin collection, thus increasing the number of M9's known in perfin hands.

W13 William Rennie Co., Ltd. Vancouver, B.C.

While attending the Toronto Philex Show early in September 1986, I purchased a Wm. Rennie cover franked with a #109, the 3¢ Carmine Admiral, owning only the 3¢ Brown.

The Corner Card reads; If undelivered return to - "Rennie's Seeds (Always grows) Cor. Adelaide and Jarvis Streets, Toronto, Canada" The postmark is the usual machine cancel with wavy lines -Toronto, Ont. Postal Terminal A d/Nov. 8, 3.30 pm, 1924.

The cover is perhaps unusual in that after returning home I discovered that the Perfin on #109 had a lovely code hole after the 'Co.' quite visible in the wide right margin, making this a Vancouver office perfin used on cover at H.O. Toronto - addressed to Arichat, N.S.

The present latest date in the Handbook is 1919/04/29 which on checking was a reporting from my own Vancouver use cover bearing a 2¢ Carmine Admiral. The above 1924/11/8 moves the verified date of use of W13 forward about five and a half years and also adds the fact of the Vancouver office Code hole stamp being used out of the Toronto H.O. A further check of all W13 Perfins might reveal that other stamps were used atToronto.



J4 Finally Identified

A member of the Perfins Club obtained the perfin cover shown below. The perfin on the cover is J4, JEP/SON. There didn't appear to be a connection between the addressee and the perfin but he wrote to the address on the cover in an attempt to find something about the Jepson initials if at all possible. The result certainly was interesting.

Firstly, the Winkley A.L. Company had moved to a new address in 1969, seventeen years ago, yet the U.S. Post Office managed to deliver the letter to the new address with only a few days delay at most.

Lowell E. Jepson founded the Winkley Artificial Limb Company in 1888. The company was founded to manufacture and fit artificial limbs and it continues to do so today on an international basis. At one time Winkley was considered to be the largest manufacturor of artificial limbs in the world. The firm continues to be a family operation and is presently managed by the fourth generation of family owners. At one time the firm operated with the subtitle of Jepson Brothers. It is nolonger known if the initials are a reference to the founder or the subtitle name. Either way, the J4 perfin has now been confirmed without question.

As illustrated, New York Life perfins are often encountered with the perfin design centered to the top or bottom and showing only one of the Code Holes, (L) 15. The necessary combination of the code Hole 'B' or 'C' is not present, and positive identification of the office user on such single stamps may be abondoned.

Rather than setting such stamps aside in a (?) or unidentified envelope, identification is quite possible by matching the partial design to the N11 or N12 Handbook illustrations which are both extremely accurate reproductions. The

No. 15 Code Hole for the N11 Quebec design is slightly closer to the stem of the "L" than in N12, and the Code Hole No. 15 of the Quebec design will not exactly line up with the No. 15 of the Vancouver design. Also the Code Hole for N11 Quebec is slightly upwards from its horizontal counterpart in the "L" stem, while in N12 Vancouver, the Code Hole No. 15 has a slightly downwards position.

Personally, from long standing habit, I had previously checked only the numbering Codes for New York Life design and if the office location could not be determined readily because of hole or cancel absence, the stamp became an immediate discard. This system of matching a partial perfin design to the Handbook illustrations may be workable for other office similarities existing within this perfin.

If similar work has already been recorded by others, the above Quebec/Vancouver identification may bear repeating for newcomers and others now working on this popular perfin.

If you have them in C52 (as I did), check the "R" against the catalogue illustration. They are probably C51. If you have any subsequent issues after # 440 with code holes, please let me know, preferably with a photocopy so that I can use it in another issue of the Perforator.
