



CIGARETTE CUSTOMS STAMPS 1880 132 X 15 MM - LITHOGRAPHED

The custom stamps consists of two types, type I with a plain rosette at left and type II inscribed "NOT MORE THAN" around the rosette. Most full sheets consist of two panes of 12 side by side or 24 stamps to the sheet. Sheets of 12 and 18 stamps are known. The watermark is the block type and as usual, does not cover all 24 stamps in most cases. Two and sometimes three stamps in the sheet will miss the watermark. All stamps of both types are blue.




