CIRCULAR No. 200.

TO LOCAL MANAGERS:

The issue of Annual Card Passes covering the use of this Company's Long Distance Lines will be discontinued on and after January 1st, 1908.

The issue of Coupon Franks, for 1908, will be of three classes:

SERIES A—PERSONAL.

"B—EMPLOYEES.
"C—CONTRACT.

These Coupons are only valid for this Company's line charge between points in Canada.

On and after January 1st, 1908, all Long Distance business must be accounted for as "Paid" business.

Holders of Coupon Franks are privileged to settle for Long Distance Tolls between points in Canada with such Coupons. As Coupons accepted in payment of such business represent their equivalent in cash, they must be treated and cared for as cash, and at the end of each month taken to credit and remitted in the following manner:—

Take credit in Balance Sheet by entry worded as follows:

The Coupons and Form No. 274 must be enclosed in a sealed envelope and forwarded with the Balance Sheet in which credit is taken. The name of the Agency, month and amount must be endorsed on the envelope.

As no revenue is derived from the issue of Personal and Employees' Coupon Franks, the commission taken on such business in the month in which it occurred, must be debited back in the Balance Sheet which contains the Coupon remittance credit, in an entry worded as follows:

### EMPLOYEES' FRANKS.

A new form of Frank will be issued, and on and after the 1st of September will cover the use of the Company's toll lines by Officials and Employees on the business of the Company. These Franks will be furnished in two styles, "LIMITED" and "UNLIMITED," bound in book form of fifty Franks to the book.

Applications for Franks must follow the regular lines of authority until approved by the General Manager, but renewals will be issued by the Secretary on request of Division Officials.

Officials on whose authority Franks are issued, will be held responsible for the return of unused portions of Franks, when the Holder leaves the service or is transferred.

The "Limited" Frank is to be used in payment of a single message when the employee is away from his office. Each Frank must be filled in to show the name of the person spoken to, the names of the offices between which the conversation took place, the date of the message, and the amount of the toll charge, and must be signed by the Holder.

The "Unlimited" Frank is to be used in payment of two or more messages appearing on one toll bill, such as a mouthly office bill. Each Frank must be filled in to show the number of messages covered, the date of the account, the total amount of the toll charges, and signature of the Holder.

These books are provided with stubs which must be filled in when the Franks are used, thus giving the Holder a protecting record.

The reversal of toll charges will not be permitted under these Franks, excepting reversals to the Holder's own office.

This plan contemplates a reduction in the number of Frank Holders, and closer supervision by by the higher officials of the use of the lines on Company's business.

Employees having toll accounts rendered against their offices must check the same carefully. If correct, the accounts should be initialled and mailed to District Superintendent or District Plant Chief, who, after satisfying himself that the messages are properly payable by Frank, will draw an "Unlimited" Frank in payment thereof, and forward the bill with the Frank attached to the billing office.

Employees who are acting for both the Operating and Plant Departments will have their business franked by the District Superintendent. Should the latter consider that the use of the Company's lines by any such employee is excessive, he shall return the bill and have the messages on the business of the Operating Department indicated by an "O" and those on the business of the Plant Department by a "P," so that he and the District Plant Chief, to whom he will submit the Plant portion of the bill, may decide whether there has been any abuse of the lines in connection with the business of either Department.

Franks received in payment of tolls during the month should be retained until Form No. 3-D is completed, credited therein (enclosed in an envelope with Form No. 274), and forwarded with the No. 3 D to the Auditor. All "UNLIMITED" FRANKS should have a copy of toll bill attached.

Franks must not be accepted in payment of messenger service nor for local exchange calls at Public Pay Stations.

At Commission Offices, no commission will be allowed on business covered by these Franks, and should be debited in No. 3-D the same as heretofore.

All Employees are again reminded that the use of our toll lines for official business must be restricted in every possible way. Our lines should not be used (to the loss of public business) when regular correspondence by mail would be equally satisfactory.

This circular cancels all instructions heretofore in effect in regard to the use of toll lines on Company's business, and Series "B" Franks will not be accepted for conversations which take place after the 1st of September, 1911, and should be returned to the office of issue.
