Enclosed with this month's Newsletter is a continuation of my study of the Vacation-with-pay Provincial Stamps. The colors are:

Manitoba - 1¢ - 2¢ - 5¢ purple; 10¢ brown; 25¢ orange; 50¢ red with blue control number and Jim Lehr reports his copy with a red control number; \$1 green with red control number. I know that there is a \$5 value, but I have never seen this.

New Brunswick - 1¢ dark grey; 2¢ brown; 5¢ yellow; 10¢ green; 25¢ orange; 50¢ blue; \$1 red; \$5 purple.

Nova Scotia - 1¢ yellow; 5¢ pinkish red; 10¢ purple; 25¢ blue; 50¢ brown; \$1 green; \$5 orange red. All values have the denominations printed in black.

Ontario - 1¢ to \$1 brown grey; also \$1 red; \$5 blue. The last two have the denomination printed in black.
