At the Annual meeting <u>Sid Bedwell</u> had a xerox of Poster illustrating the British Columbia Law Stamps and giving the history of Law Stamps. The Poster measures 17" x 22" and it is for sale by the British Columbia Law Courts, price \$50.

Below I have copied the information on the Poster sell store Indiata

"Her Majesty, by and w ith advice and consent of the Legislative Assembly of the Province of British Columbia enacted an act respecting Law Stamps cited as "Law Stamp Act, 1879". It provided for the use of Law Stamps in lieu and in payment of the fees and charges due to the Crown upon legal proceedings"

"Almost all provinces of Canada issued Law Stamps at one time or the other and the Law Stamps of Upper a nd Lower Cana da and Manitoba preceded the ones issued in the Province of British Columbia" is been view as to done with the good description with the second statements

"Unlike most of these provinces, where the use of Law Stamps wa s discentinued long ago, British Columbia still iss ues Law Stamps today. Most Court Registries, however, new only use meter impression machines to register filing and service fees according to tariffs laid down in the Spreme Court rules and the use of Law Stamps once widespread, is not limited to but a few, small locations. It is therfore expected that these colorful issues will soon be a thing of the past." "During the 100 years that Law Stamps have been issued, nearly 15,000,000 were affixed to legal documents, using 11 different denominations, Twelve different series can be recognized, each one quite distinct from the others by pecular features of the design or perforations, Each series has been named according to these distinctive features or in recognition of some Registries and the Province of British Columbia"

"All Law Stamps issued in British Columbia have the Godess of Justice, Themis, as the central figure, surrounded by the words "British Columbia Law Stamp" and the value of the respective denomination, The only exception is a series of 5 Law Stamps issued in 1956, commemorating 100 years of the administration of Justice in the Province of Eritish Columbia. Each stamp depicts one of the original Court Houses in the Province."
