## The Canadian Revenue Society

The Canadian Revenue Society was founded in 1938. During their existence the CRS published at least 25 studies and publications, these studies were made by such atudents of Canadian Revenues as Dr. DeL French, R. A. Odell Nelson Hond, E. L. Piggott, C. Armstrong, C. D. B. Garrett, B. Pelletier, Colin Makepeace, Arthur Ayre, Dr. Novotney. Many of these publications are still the best reference material available.

Roger DeL French was secretary, he published 142 Bulletins. The Canadian Revenue Society became the Revenue Group of BNAPS in 1954. Therefore we are 30 years old.

Between 1962 and 1968 Ed Richardson published the Canadian and BNA Revenue Yearbook "Charter Membership Edition" with 64 Charter Members of which 16 are still members of our Revenue Group. We still have 6 members who were original members of the Canadian Revenue Society.

Ed Richardson published 12 Newsletters In 1971 Bill Rockett took over as Editor of the Canadian Revenue Newsletter. So far he has published 138 Newsletters.

We expect to be in Quebec for the Royal Convention May 18/20 We hope to have a Revenue Seminar. Be sure to attend if you are there.
