Attached are photocopies of several documents with 2nd and 3rd issue Alberta Law Stamps affixed. As you see, just about anything could get a stamp.

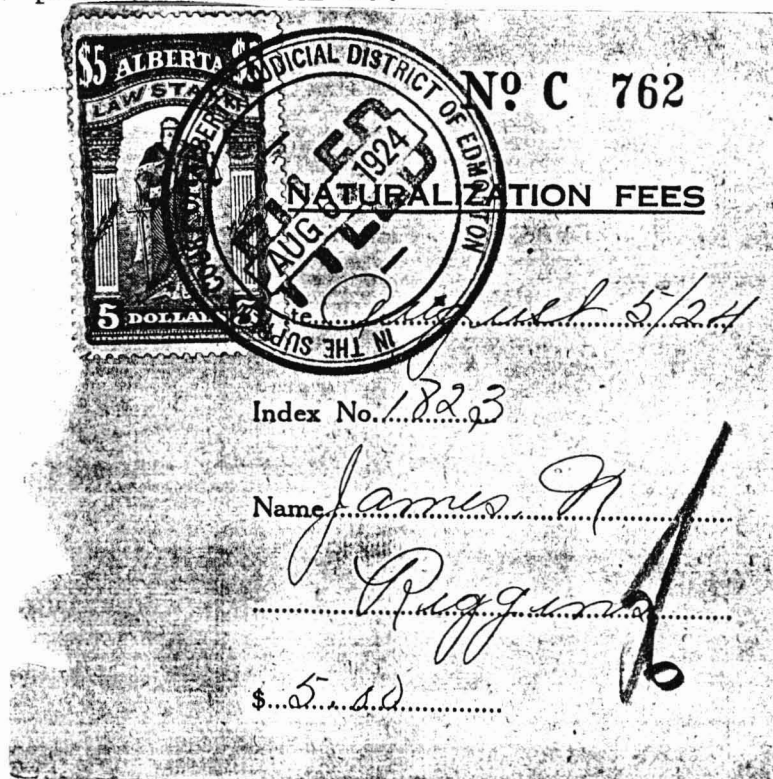
