

### The 'Companies' We Keep

It has always surprised me that there is little or no interest in the cancels on Canadian revenue stamps. With postage stamps one has town cancels, RPO's, and perfins, and yet as revenue collectors we have ignored one of the more interesting parts of the hobby – company cancels.

In 1865 the bill stamp act was amended to allow the use of hand stamped cancels. For the revenue collector this opened up an entirely new area just as interesting and challenging as the cancels on postage stamps. Each company cancel represents a brief

glimpse at our history, the people involved and the taxes they paid and they represent almost every kind of business imaginable, from maltsters to candlestick makers, merchants to insurance agents.

My collection represents only the cancels I have found on the 2nd issue bill stamps. Of these 40 odd cancels, two items standout from all the rest. These are the cancels of two of Canada's past leading citizens, William Price and John Redpath.

#### William Price - Lumber Merchant in Quebec

William Price was born at Hornsey, London, England on the 17th of September 1789. At the age of 14 he began his career working for Christoper Idler, a London businessman, importer of wines, lumber and other goods. He arrived in Quebec at the age of 21 working as a clerk in a branch of the Idle firm. It is believed that the Idler firm had obtained a monopoly on Canadian lumber orders for the British Admiralty at the beginning of the Napoleonic Wars.

Poor management of the Idle firm in England had brought the company to near ruin and Price, with 10 years experience behind him, began looking around for financial backers and a partnership. He finally decided on Parker and Yoeman, timber merchants of London, and the firm William Price Company of Quebec was formed in





May of 1820. Price primarily exported square timber and planks for the shipyards of the Admiralty. He acquired substantial reserves of timber; over 7,000 square miles of forest along both sides of the Saguenay in addition to timber limits in the Ottawa valley. He began by erecting saw mills and then encouraged other owners of mills to increase their production, even finance them, and eventually acquired the mortgages of the mills. From 1820 to 1850 Price and his partners had a fleet of over 40 vessels shipping lumber to the British Admiralty as well as Canadian and American markets.

By 1843, things started to change for Price as he began to lose his monopoly on Canadian timber just at a time when the English market was shrinking. Near bankruptcy almost brought the partnership to an end and the next four years were spent fighting to preserve the forest empire Price had built for his three sons.

By 1849, business had recovered and Price through the income from his own sawmills was able to buy out his partners. In 1855 his dream was realised with the founding of the company William Price and Sons.

In January 1867, notice was given in the Canada Gazette that William Price was retiring from the firm and the business would be carried on under the name of Price Brothers & Co.

NOTICE is hereby given that William Price, has retired from the firm of William Price & Son, owing to the infirm state of his health; the business of said firm will be hereafter carried on by the undersigned, under the name and firm of Price, Brothers & Co.

### John Redpath – Founder of the Canada and Dominion Sugar Co.

John Redpath was born in 1796 at Earlston, Berwickshire, Scotland. A stone mason, Redpath came to Montreal in 1816 - he was 20 years old. He wasn't in Montreal very long before he became a major contractor in Montreal supplying stone for the new Notre-Dame church.

Redpath, and his partner, Thomas McKay gained their reputation for the building of the Lachine canal and the locks at Jones Falls on the Rideau canal.

By 1855 he was one of Montreal's wealthiest citizens with interests in shipping, banking, mining, insurance and Peat fuel as well as holding a position on the Board of Directors of the Bank of Montreal.





It was at this time that Redpath began construction of his 7 storey sugar refinery, Montreal's first, and one of the cities leading landmarks. With a year he was employing over 100 people, producing 3,000 barrels of refined sugar per month from cane sugar imported from the West Indies on his own ships.

In 1859, Redpath brought his eldest son, Peter, and his son-in-law, Alexander Drummond into the firm, who ran the company jointly after his death in 1869. (Continues on page 10.)

## A Scarce Example of the War Exchange Tax on Periodical Publications Christopher D. Ryan



Illustrated above is a March 1942 mailing label from a wrapper or envelope that once enclosed a copy of the American periodical *House & Garden*. Affixed to the label is a four-cent American postage stamp paying the second-class rate to Canada of one cent per four ounces, or fraction thereof. However, what causes this item to be of particular interest is its franking of Canadian revenue stamps. These stamps comprise three different denominations from three different issues and, together with the postage stamp, produce a scarce and attractive display piece.

From June 25th, 1940, through October 12th, 1945, most newspapers and magazines imported into Canada from the United States of America were subject to a 10% excise tax, the War Exchange Tax, that was applied to nearly all importations from non-British countries. The Statute required that this tax be paid at Customs by the importer or his agent. Beginning in late July of 1940, Canadian revenue stamps were permitted as a means of pre-paying this tax for magazines and other periodicals sent into Canada by mail. For this purpose, ¼ and ½-cent excise tax stamps, along with 1, 2, 5 and 10-cent customs duty stamps, were sold by the Revenue Department to American and other foreign publishers. The amount of tax payable in stamps on each copy of a

mailed periodical was to be 10% of the average subscription price per issue. The value of the stamps affixed was to be rounded to the nearest quarter-cent with a minimum of one-quarter cent per copy of a taxable periodical.

The one and three-quarters of a cent excise tax on the copy of *House & Garden* is paid by three different denominations of revenue stamps: 1-cent, ½-cent and ¼-cent. This would seem to be an unnecessarily cumbersome franking for what is a relatively minimal amount of tax. But given the denominations available to publishers, this is the fewest number of stamps that could have been used in this instance. However, the presence of multiple revenue stamps is a common feature of such covers. The primary significance of this particular item is the issues of stamps used. Three separate series of Canadian revenue stamps are represented in the franking: Second Issue customs duty, Three Leaf excise tax and George V excise tax. To the best knowledge of this writer, covers showing use of the quarter-cent George V excise tax stamp for the 10% War Exchange Tax are scarce. The presence of this stamp on a cover in combination with both customs duty and Three Leaf excise tax stamps makes that cover a highly prized example of the tax.



Description: Black on orange with light orange recycling symbols in background and white areas in graphic at right, black serial number between parallel lines of micro printing, 153 by 35 mm. Cost: \$2.00 each. Comments: All bags must be tagged. Adelaide-Metcalfe was created on January 1st, 2001, by the amalgamation of Adelaide and Metcalfe townships. (See **Bluewater Recycling Association** below.)

Municipality of ARRAN-ELDERSLIE (pop: 6577) in Bruce County

Description: Black on fluorescent green, 216 by approx. 39½ mm (width varies within the sheet). Cost: \$2.00 each, sold in sheets of 7. Comments: Residents allowed 2 untagged bags per week, excess to be tagged. In the three sheets of 7 seen by this writer, only the top stamp has the complete name of the municipality present in the ribbon under the municipal arms. The lower 6 tags in the sheets are missing the centre portion of the name. Arran-Elderslie was created on January 1st, 1999, by the amalgamation of Arran and Elderslie townships with the villages of Tara and Paisley and the town of Chesley.

 $Township of {\bf ASHFIELD-COLBORNE-WAWANOSH} \ (pop: 5411) \ in \ Huron \\ County$ 



Description: Black on dull orange, 127 by 24 mm. Cost: \$1.50 each. Comments: All bags must be tagged. ACW was created on January 1st, 2001, by the amalgamation of Ashfield, Colborne and West Wawanosh townships.

#### **BLUEWATER RECYCLING ASSOCIATION**




Description: Black on orange with dark blue recycling logo, 140 by 31½ mm. Cost: \$2.00 each. Comments: The Bluewater Recycling Association (BRA) is a group of municipalities in southwestern Ontario that have pooled their resources to provide viable recycling programs for their residents. Beginning in May of 1996, the Association added garbage to its roadside collection services to make its operations more cost-effective.

During late-2004, the tag illustrated here was in use in South Huron as an interim measure pending the arrival of a new supply of the Municipality's own

tags early in 2005. The extent to which this tag was used in past years, by South Huron or other municipalities, is not known to this writer.


Starting in 1999, members of BRA adopted a common design of tag that differs from the one shown here. This new design, an example of which is shown above for the Township of Adelaide-Metcalfe, bears the respective municipal arms or logo at left and the name of the Association in micro printing that frames the serial number at right. A variation on this design was introduced in July 2004 in Southwest Middlesex (see below). This second type is slightly smaller with wider digits in the serial number and different sizes for the text and graphic.

Description: Red on white, 89 by 68½ mm, black serial number. Cost: \$1.50 each. Comments: All bags must be tagged. Brockton was created on January 1st, 1999, by the amalgamation of Brant and Greenock townships with the town of Walkerton.


Description: Black on green, 102 by 23 mm. Cost: \$2.00 each. Comments: All bags must be tagged. Large items, such as furniture, require two tags.

Chatsworth was created on January 1st, 2000, by the amalgamation of Holland and Sullivan townships with the village of Chatsworth.

Town of COLLINGWOOD (pop: 16,039) in Simcoe County



Description: Orange on white, 102 by 76 mm. Cost: \$1.50 each. Comments: Residents were allowed 3 untagged bags per week, up to 3 additional tagged bags will also be collected. As of January 1st, 2005, Collingwood tags were replaced by those of Simcoe County with a new limit of 2 untagged bags.

Town of **DESERONTO** (pop: 1796) in Hastings County

Description: Light green on white, black serial number, 151 by 12½ mm. Cost: \$1.00 each, produced in sheets of 10, each sheet is rouletted horizontally down its centre to permit sales in multiples of 5. Comments: All bags must be tagged.

Township of **Drummond/North Elmsley** (pop: 6670) in Lanark County

### DRUMMOND/N ELMSLEY TWP. GARBAGE LABELS RECYCLE.

Description: Blue on white, 149 by 12½ mm. Cost: \$1.00 each. Comments: Residents allowed 2 untagged bags per week, excess to be tagged. Drummond/ North Elmsley was created on January 1st, 1998, by the amalgamation of Drummond and North Elmsley townships.

These complimentary tags differ in several details (black text colour, absence of frame line in logo, no numbering, smaller size) from the tags that are sold for \$1.50 each (*CRN* № 46).



Since January 1<sup>st</sup>, 1998, Fullarton has been part of what is now known as the Municipality of West Perth (see 'West Perth' below), but the old tags are still in use (October 2004).



Greater Napanee was created on January 1st, 1998, by the amalgamation of Adolphustown, North Frederickburgh, Richmond and South Frederickburgh townships with the town of Napanee.

Municipality of GREY HIGHLANDS (pop: 9196) in Grey County



Description: Black on light green, 150 by 25 mm. Cost: \$1 each. Comments: All bags must be tagged. Eligible payers of municipal taxes receive an annual allotment of 'free' tags. Grey Highlands was created on January 1st, 2001, by the amalgamation of Artemesia, Euphrasia and Osprey townships with the village of Markdale.

Town of HANOVER (pop: 6869) in Grey County.



Description: Black on orange, black serial number, 101 by 25 mm. Cost: \$1.00 each. Comments: All bags must be tagged. Eligible payers of municipal taxes receive an annual allotment of 'free' tags.

Description: Black on orange with light orange recycling symbols in background and white areas in graphic at right, black serial number between parallel lines of micro printing, 153 by 35 mm. Cost: \$2.00 each.

Comments: All bags must be tagged. In Brussels Ward (pop: 1143) a green (\$1.50) tag must be affixed. In the Grey (pop: 1943), McKillop (pop: 1266) and Vanastra (pop: 650) portions of the municipality an orange (\$2) tag must be affixed. In the Seaforth and Tuckersmith sections garbage collection is private. Huron East was created on January 1st, 2001, by the amalgamation of Grey, McKillop and Tuckersmith townships with the village of Brussels and the town of Seaforth. (The population quoted for Vanastra is an approximation provided by Huron East.) (See **Bluewater Recycling Association** above.)

Comments: No roadside garbage pickup. All bags brought to the Logan municipal landfill must be tagged. Since January 1st, 1998, Logan has been part of what is now known as the Municipality of West Perth (see 'West Perth' below), but the old tags are still in use. The serial numbering in the sheets runs from bottom to top.

Description: Black on orange with light orange recycling symbols in background and white areas in graphic at right, black serial number between parallel lines of micro printing, 153 by 35 mm. Cost: \$2.00 each. Comments: All bags must be tagged. Lucan-Biddulph was created on January 1st, 1999, by the amalgamation of Biddulph township with the village of Lucan. (See **Bluewater Recycling Association** above.)

Description: Black on shiny dark orange on white with blue recycling logo, 152½ by 32 mm. Cost: \$1.00 each, sold in sheets of 5. Comments: All bags must be tagged.

Description: Orange on white, black serial number, 102 by 76 mm. Cost:\$2.00 each



Description: Black on orange, 127 by 28 mm. Cost \$2.00 each. Comments: The orange & white tag was the first design to be used. In January of 2001, the Town of Meaford merged with the adjacent townships of St-Vincent and Sydenham to form what has been known since March 5th, 2001, as the Municipality of Meaford (pop: 10,381). The old town tags are now used throughout the new Municipality. At present, residents are allowed one untagged and one tagged bag per week.

Since January 1st, 1998, Mitchell has been part of what is now known as the Municipality of West Perth (see 'West Perth' below), but the old tags are still in use, to be replaced by 'West Perth' tags once the stock on hand is exhausted.

Description: Black on shiny yellow, 1381/2 by 25 mm. Cost: \$1 each, sold in sheets of 10. Comments: All bags must be tagged. Furniture and oversized bags require two tags. Morris-Turnberry was created on January 1st, 2001, by the amalgamation of Morris and Turnberry townships.

Description: Black on orange, black serial number, 179 by 35 mm. Cost: \$1.00 each.



Description: Black on fluorescent orange-red, black serial number, 108 by 94 mm. Cost: \$20 each.

Comments: Residential properties of 5 or less units are allowed 2 untagged bags per unit per week, excess to be tagged. Freon containing appliances must be affixed with a \$20 tag, which covers the cost of removing the gas.



The title of 'municipality' was adopted on July 14th, 2003.



Comments: Schools under special contracts, as well as all municipal agencies, boards, commissions and departments, that receive roadside pickup of individual bags of garbage by the City must affix a \$2.00 tag to each bag.

All businesses that receive roadside pickup of individual bags of garbage by the City must use the yellow bags. Items too large for a bag must be affixed with a \$3.10 tag. Regulations state that tags are not to be used by businesses on regular garbage bags, but this writer has regularly seen tags used in this manner. The vertical bar-code at the near right represents the serial number. The horizontal bar-code at the far right is the price-code for the tags.

In 2004, it was discovered that counterfeit Type 1 bags were being used. The alleged perpetrator has been arrested and the City introduced the Type 2 bag as a guard against future fraud. The new bags have special markings that are only visible under UV light. The old bags were not recalled and will continue to be collected until supplies on hand are exhausted.

The present City of Toronto was created on January 1<sup>st</sup>, 1998, by the amalgamation of the old city of Toronto with the cities of Etobicoke, Scarborough, North York and York, as well as the borough of East York.







### The 'Companies' We Keep (Continued from page 1.)

In 1876, with steep competition from U.S. imports and the loss of protective tariffs by the Canadian Government, it was no longer profitable to continue operating so the company laid off the last of their workers and remained idle for three years.

With John A. MacDonald's victory in Parliament in 1878, the new government provided the protection the company needed to operate. The company re-opened as the Canada and Dominion Sugar Refinery Company Limited.
