INTRODUCTION

This is the third of the series of newsletters looking at the Trans-Atlantic aspects of PEI mails. It will concentrate on the rates, routes (more on this in #70) and the use of adhesive stamps in the period 1861 to 1873.

There will be at least one other issue devoted to PEI, adding to the information already published (in particular the Eighteenth Century) and including the comments received. If space allows it will include further examples of unusual rates.

THE RATES AND ROUTES IN FORCE IN THE PERIOD 1854-1873

By way of a reminder, the rates applicable between the United Kingdom and PEI from the reductions in 1854 to the date that PEI joined the Dominion of Canada are listed below. These rates are similar to those for the remainder of British North America, but there are differences in some aspects:

Trans-Atlantic ship letters to PEI in this period are unknown.

Carriage by United States Packet is virtually unknown (at best exceptional).

Carriage viâ the United States is unknown until the completion of the railway from the New Brunswick Border with the United States to Shediac was complete, and rare after that.

The great majority of letters were carried viâ Halifax, Nova Scotia.

I would add one caveat to the last observation: I have recently seen a letter from Nova Scotia endorsed 'Per Steamer Lady Head Via River de Loup', presumably intended to connect with the Canadian Packets. I had not previously considered this an option and it is possible that mail from or to PEI could have been directed in this way. Your views would be appreciated.

The rates are fairly straightforward, although the dates of their implementation occasionally are different from the remainder of BNA. For instance:

Fines were introduced on unpaid or underpaid mail with Canada from 1st April 1859. On the insistence of the PEI authorities that the post offices on the island did not accept unpaid mail (which was not absolutely correct, qv, TANEWS #66), this regulation was delayed in implementation in PEI and became effective on mail between the UK and PEI only on 1st June 1860. Letters could be sent unpaid to and from PEI, without being fined, for a little over a year longer than Canada.

PEI was omitted (I believe unintentionally) from the instruction which authorised the postage rate reduction of 6th January 1870; this was corrected only from 9th May 1870. So, for a brief period, letters to and from PEI cost twice as much as those between the UK and the Dominion.

I have not included the trans-Atlantic rates after PEI joined the Dominion of Canada; they were the same as for the remainder of the Dominion.

THE ADHESIVE STAMPS

I know little or nothing about stamps, and have relied entirely on James Lehr's book 'The Postage Stamps and Cancellations of Prince Edward Island' for the information reproduced in the list below. The list includes all the stamps in outline (I have not dwelt upon specifics of perforation varieties or paper colours) and would draw your attention to just a few aspects:

The values on the majority of stamps are shown only in PEI Currency - the 9d Cy (6d Stg) and 4½d Cy (3d Stg) stamps, which were intended specifically for letters to the UK, indicate the value in both Cy and Stg.

Other stamps were used occasionally for trans-Atlantic letters (the 9d Cy stamp was not available for some months after the others were issued).

This can lead to confusion: for instance, the 1861 cover prepaid with PEI 3d and 6d Cy stamps (Figure 1), is actually the 6d Stg rate viâ Halifax, Nova Scotia; the one with two PEI 3d Cy stamps (Figure 9) is the 4d Stg rate by British Packet viâ the United States.

With the introduction of decimal stamps, the exchange was 2c PEI Cy: 1d Stg.

FRONT COVER ILLUSTRATIONS

Figure 1: (Provided by Martyn Cusworth.) Figure 1 shows a letter prepaid 9d Cy (6d Stg) carried by British Packet (Cunard Line 'Canada' out of Halifax on 6th September 1861, arriving at Liverpool on 15th September 1861). The 9d Cy/6d Stg stamps were not available until late 1861. This was the rate established by Treasury Warrant effective 23rd March 1854; the Cunard Line provided a fortnightly service, using vessels en route to and from Boston (for Halifax calling dates see JC Arnell 'Atlantic Mails'). The contract passed to the Inman Line at the end of 1867 and to the Allan Line in 1871.

Figure 2: (Provided by Allan Griffiths.) From 1854, the rate viâ the United States was 8d Stg, 1s Cy; it was reduced to 7d Stg, 10½d Cy in 1868 and to 4d Stg, 6d Cy in 1870. This last rate became 8c in 1872.

Figure 2 shows the cent rate; the letter was carried by British Packet (the Cunard Line 'Algeria', departing New York 3rd April 1872, arriving Queenstown 12th April 1872). It is the only example of this rate from PEI recorded after the issue of the decimal stamps, which were in use for only eighteen months.

1854 - 1861: UNITED STATES PACKET

The cover which follows doesn't really belong in this section, but is so unusual it cannot be left out. It is a letter carried by the New York and Le Havre Steam Navigation Company's ship 'Arago'. Posted unpaid it was charged 1s Stg plus an extra penny on arrival.

1s was the standard charge for a letter from the UK to the US under the 1848/9 Anglo/US Convention and remained in force until 1st January 1868, when it was reduced to 6d/12c.

The shilling would have covered the charge to the US Border (with New Brunswick). I have been told that the extra penny was a ship master's gratuity, in other words that the letter was carried from the US to PEI by private ship. I cannot prove the matter one way or another, but would rather think that it was 'provincial' postage, in the same way that the 6d and 8d rates each included a 1d provincial inland postage. The 1s 1d Stg charge was converted to 1s 7½d PEI Currency.




Figure 3: London, England to Charlottetown, PEI, 23rd September 1856 (courtesy Allan Griffiths).

BRITISH PACKET VIÂ THE UNITED STATES

The first letter on this page is from an earlier period: from 15th April 1849 the rate from the UK 'to any port or place in Canada, New Brunswick, Nova Scotia or Prince Edward Island' was reduced to 1s Stg (Treasury Warrant, 3rd April 1849); sent viâ the US the rate was 1s 2d.

The first letter was paid one 1s 2d (2d was credited to PEI) and sent by Cunard Line 'Niagara', leaving Liverpool on 15th October and arriving at Boston on 28th October 1853; but 'Niagara' called at Halifax and the letter could have been put off there. Arrival date not known.




Figure 4: London, England to Charlottetown, PEI, 14th October 1853 (courtesy of Allan Griffiths).




Figure 5: London, England to Charlottetown, PEI, 9th October 1867 (courtesy of Ron Saint).

The rate by British Packet viâ the United States was 8d Stg from 23rd March 1854 until 1st January_1868, but is rarely quoted for PEI. Figure 5 was directed 'Via New York'; prepaid 2s 6d Stg this would have weighed 1½ - 2 oz (the weight progression, allowing ½ oz increments,

changed on 1st April 1866). However, this is an underpayment of twopence (4 x 8d = 32 (2s 8d)) and the next ship to leave was the Cunard Line 'China' via Halifax to Boston. So the letter may not have travelled viâ New York after all but there must be one out there somewhere!

BRITISH PACKET VIÂ THE UNITED STATES

The rate viâ the United States was reduced to 7d Stg on 1st January 1868; there was only a brief period until it was again reduced on 9th May 1870. Figure 6 was carried by Cunard Line 'Java', out of Liverpool 26th June 1869, arriving at New

York on 6th July 1869; Figure 7 was also carried by 'Java', out of Queenstown on 23rd May 1869, arriving New York on 1st June 1869. No examples of the reciprocal rate, 10½d Cy out of PEI, are known.

BRITISH PACKET VIÂ THE UNITED STATES

The rate viâ the US was reduced to 4d Stg, 6d Cy (later 8c, see Figure 2) on 9th May 1870. Figure 8 shows a letter from England prepaid 4d and directed 'Qtown and New York'.

The letter was Carried by the Cunard Line 'Russia' departing Queenstown (Ireland) on 17th September 1871, arriving New York on 26th September 1871.

The reciprocal rate was 6d Cy. Figure 9 shows a cover which was carried to Shediac, thence by railway to the US to connect with the Cunard Line 'Parthia' out of New York on 9th March

1871, arriving at Queenstown on 19th March 1871. As far as I know, this is the only example of a PEI pence cover carried by British Packet out of the US.

BRITISH PACKET VIÂ HALIFAX




Figure 10: Charlottetown, PEI to Rochester, England, 23rd March 1865 (courtesy of Martyn Cusworth).

The rate between the United Kingdom and PEI by British Packet viâ Halifax remained at 6d Stg, 9d Cy from 23rd March 1854 until 9th May 1870. Letters showing the British rate are relatively common, so I have economised on space and show only PEI examples (Figures 1 and 10).

Figure 10 was prepaid 9d Cy (cancelled by the Charlottetown '13' obliterator) and bears a PEI datestamp for 23rd March 1865 on the reverse. It was carried by the Cunard Line 'Africa' leaving Halifax on 31st March 1865 and arriving at Liverpool on 11th April 1865.

The rate between the Dominion of Canada and the United Kingdom was reduced on 6th January 1870 to 3d Stg; the fine on unpaid or underpaid letters was also reduced to 3d. The reduction of the rate to PEI, which not announced at that time, was published in a GPO Notice dated 1st June 1870, although the effective date is earlier.

Figure 11 shows a letter prepaid 4½d with the PEI cds of 25th July 1870; the stamp has been cancelled by the Charlottetown '13' obliterator. The letter was carried across the Atlantic by the Inman Line 'City of Antwerp', departing Halifax on 29th July 1870, arriving Queenstown, Ireland on 6th August 1870.

BRITISH PACKET VIÂ HALIFAX




Figure 12: Charlottetown, PEI to Portarlington, Ireland, 13th July 1870 (ex RC Carr Collection).

On the transition from the 9d Cy to the 4½d Cy rate a few of the former stamps were bisected. The only such covers I have seen were in the RC Carr collection and all were used on a correspondence from PEI to Ireland. Figure 12 is one such (the other half of the stamp was used

on a cover posted two weeks earlier). Posted at Charlottetown, it was probably carried by the Inman Line 'City of Baltimore' out of Halifax on 15th July 1870, arriving at Queenstown on 24th July 1870. If the present owner could confirm the arrival date ...

THE CENTS PERIOD




Figure 13: Charlottetown, PEI to Truro, Cornwall, 14th May 1872.

When PEI adopted decimal currency on 1st January 1872 a 6c stamp was introduced for the 3d Stg trans-Atlantic rate (it also covered the rate from PEI to the US). Figure 13 is one of the only two covers recorded for this stamp used on trans-Atlantic mail. It was carried by the Allan Line 'Caspian' out of Halifax on 21st May

1872, arriving at Queenstown on 30th May 1872. It appears that 'Caspian' (by now the Allan Line had replaced the Inman Line on this route, and 'Caspian' was thus a 'British Packet') continued on to Liverpool with some of the mails. The cover has a Liverpool transit handstamp of 31st May 1872.

UNDERPAID LETTERS

Very few underpaid letters from the UK to PEI after 1860 have been recorded; none are known from PEI. From 1st June 1860, letters unpaid or underpaid were charged the deficiency plus a sixpence fine; the fine was reduced to threepence when the rate was reduced in 1870.




Figure 14: Liverpool, England to Summerside, PEI, 15th January 1870.

Figure 14 was mistakenly paid 3d as though for the Dominion of Canada; as the rate had not been reduced to PEI, it was underpaid 3d. The fine was still 6d. The British Post Office has claimed 6d: 3d the deficiency, plus 3d the half fine. The total charge was 9d Stg, 1s 1½d Cy.

Figure 15 was paid 3d Stg for the Halifax route, but was directed 'via New York' and was thus underpaid a penny and subject to a 3d fine. The GPO marked it as deficient '1d' and claimed the

half fine ' $1\frac{1}{2}$ '. The total amount due in PEI, including the other half of the fine, was 4d Stg, 6d Cy, this was marked in manuscript and charged to the addressee.
