RULES AND REGULATIONS

1. This Department shall function entirely for and in the interest of the membership of the British North America Philatelic Society. Any Member, in good standing, may participate in the Department and, by his participation, attests and agrees to abide by the Rules and Regulations of the Department. Any Member, so participating, may be denied such participation for infraction of any of the Rules or Regulations of the Department.

2. The President of the Society shall appoint a Member to serve as Sales Manager who shall be responsible to the Board of Governors. The President of the Society shall appoint a Committee to serve as a Board of Examiners to examine any and all stamps or books of stamps submitted to it by the Sales Manager and to order removed any such stamps or other material entered which, in its opinion, is of a questionable character, without any responsibility or liability therefore to the owner or anyone else.

3. The Sales Manager shall keep accounts and records of all transactions of the Department in such books of the Society so provided by it. He shall at specific times, provide the Board of Governors with reports of the affairs of the Department, including a full balance sheet of all bookkeeping entries and shall similarly cause such reports to be published in BNA TOPICS.

4. Members entering material for sale through the Department shall mount their material in such books as shall be prescribed by the Board of Governors. Books shall be obtained from the Sales Manager upon request and at such price as shall be determined by the Board of Governors. No other books or forms except the prescribed ones shall be used. The Department reserves the right to limit the dollar value of material entered in any one book and may reject any material which it feels will not be well received, except that such restriction shall be the joint action and decision of the Sales Manager and the Board of Examiners, without any responsibility or liability therefore to the owner or anyone else.

5. Any stamp or item which is damaged, counterfeited, re-perforated, cleaned, repaired, a reprint, or in any other way of doubtful or questionable character, must be clearly so marked next thereto by the affixer upon submission for entry in the Department books. Any such stamp or item, in any way of doubtful or questionable character not so marked clearly by the affixer, so decided by the Board of Examiners or established by any other means, in its sole discretion, and without any lia-

bility or responsibility therefor to the owner or anyone else, shall automatically cause a charge of at least 25 cents for any and each such unmarked item and be removed from the book. In instance of gross or deliberate abuse or violation of this Regulation, or where it may be deemed requisite or equitable, the Sales Manager may, at his discretion, impose reasonable additional charges, or deny the services and privileges of the Department, or both. Such gross and deliberate abuse or violation may be considered as "Conduct unbecoming a Member."

6. A charge of 2 per cent as an insurance fee shall be made of the net value of the material entered at any one time. Monies so collected shall be deposited in the Insurance Fund from which Fund claims for loss or damage to material shall be paid. The Board of Governors shall have final jurisdiction in the payment and settlement of claims.

7. A charge of 8 per cent shall be deducted from all sales made through the Department. Monies so collected shall be deposited in the General Fund of the Department, and all costs of conducting the Department shall be paid from this Fund. Both the Insurance and the Commission charges shall be deducted whenever a payment shall be made to an owner.

8. Circuits must be forwarded to the next Member shown on the Route Sheet within five (5) days of receipt by the forwarding Member, to be forwarded by him by Registered Mail insured for Five Dollars (\$5.00). Strict observance and compliance with this Rule shall be enforced by the Sales Manager and any violation shall be subject to a penalty and charge of 25 cents per book in the Circuit for each day delayed in forwarding Circuits. The loss of any material not so forwarded by Registered Mail shall be entirely the responsibility and liability of the remitter.

9. The Member, upon receiving a Circuit, shall verify the number of books in the circuit, as evidenced on the Route Sheet, and that all spaces on each page of each book contain a stamp or other item, or a proper indication that the stamp or item of the space has been sold or is accounted for.

10. The buyer must sign his name in INK (or use a suitable rubber stamp) and indicate his Society Membership Number in all spaces from which he has removed and retained an item. Each so identified purchase shall be entered on the forms specifically provided for that purpose with each Circuit.

REVISED LIBRARY RULES

1. This Department shall be maintained and shall function entirely for, and in the interests of, the membership of the British North America Philatelic Society. Any member of the Society in good standing may borrow material from the Library. Any member may be denied that privilege for infraction of the rules of the Library.
2. The Librarian shall receive and acknowledge all contributions to the Library. He shall cause to be published in B.N.A. Topics reports of all activities of the Library.
3. A member, on written application to the Librarian may have sent not more than two (2) volumes and/or ten (10) loose articles and shall not retain such borrowed material for more than thirty (30) days, at which time, or sooner, same borrowed material must be returned in good condition by the method specified by the Librarian with all charges prepaid. The member so borrowing material from the Library shall be responsible and liable to the full value of the material until same has been received by the Librarian. A member shall make such adjustment or payment for any damage or loss to the material borrowed from the Library in such amounts as shall be determined and established by the Librarian.
4. Members shall be responsible for all postage and insurance charges. No money should accompany the request for material as this will be advised at the time of shipment. Small amounts may be paid in cash, money order or postage stamps in small denomination, either Canadian or United States. Members are requested to avoid cheques drawn on U.S. banks for small amounts.
5. To avoid long delays in the return of material to the Library, there shall be a charge of \$1.00 per week or part thereof for material borrowed from the Library and held in excess of thirty (30) days. A rental of twenty-five (25) cents or more per thirty (30) day period may be charged for any special or rare book when so determined by the Librarian.

Annual Meeting

I would like especially to mention our chairman of the board, treasurer, sales manager, librarian, advertising manager

and circulation editor all of whom have by their efforts contributed to my two pleasant years in office.

The editor of Topics deserves a very special mention. I know that our magazine is often late in reaching members. This has been partly due this last few months to our Post Office employees' strike, printer's holidays in early August and the hazards of delivery by third class mail, but also partly due to the fact that our editor has been exceedingly busy in his employment and we who are close to him wonder sometimes how he is able at all to edit Topics and to give us such an outstanding magazine.

In expressing the appreciation of the Society for outstanding efforts during the year I am sure you would all wish to join me in congratulating Mickey and Ed Richardson in organizing such a grand convention.

My closing comment to all members is to request that we continue to give our full support to all our officers and to invite suitable new members to join our Society and to share our pleasures.

INTERIM REPORT OF THE TREASURER

The Annual Report of the Treasurer for 1967 was published in the June-July issue of Topics, so I will only give you a comparison between the actual and estimated results of last year's operation.

At Alpine Inn last September, I estimated that we would show a deficit of \$383.00. The actual surplus was \$836.00. Despite rising costs in every phase of the production of Topics, we continue to generate surpluses.

I believe at this time we should recognize how well our appointive officers are operating. Of course Bob Woolley and Jim Lehr are the mainstays of our additional income and their profitable operations continue to contribute the lion's share of this surplus. Ed Whiting, our Advertising Manager; Russell McNeil, our Circulation Editor; and Stew Kenyon, our Librarian are also contributors to this surplus. And we must not forget John Young, our very able Editor who does everything within his power to keep the costs of publishing

Topics down to a minimum.

As in past years, this report does not include income or expenses connected with any of the following: The 1968 Yearbook, The Handbooks, The Sales Department or The Library. Records for these operations are either unavailable or incomplete at this time.

The total income for 1968 through August was \$5,798.00 and the expenditures for the same period amounted to \$2,934.00 leaving a balance of \$2,864.00 for expenses for the balance of 1968.

I estimate that the income for the balance of the year will be \$1,271.00, while the expenses will amount to \$4,423.00. If these estimates prove to be accurate, our deficit will be \$288.00 for 1968. The estimated expenses have a built-in provision for our ever growing Yearbook deficit.

I wish to take this opportunity to thank all the officers of this Society for their wonderful cooperation during the past year.

This report is respectfully submitted for your consideration, and I move its approval.

SECRETARY'S REPORT

To the officers and members of the British North America Philatelic Society assembled in meeting at the 20th annual convention on October 12, 1968, at the Lakeview, Austin, Texas.

It is my extreme pleasure to be with you this year at the 20th annual meeting and 25th anniversary of our Society.

Your Secretary is responsible for maintaining an accurate and up-to-date listing of the membership both for official records and for mailing purposes by our mailers. I wish to express my sincerest appreciation to our Circulation Manager, Russ McNeil, for his complete co-operation and very fine assistance to a present accurate and up-to-date mailing list. I must again remark and request that members please co-operate and direct all requirements of address variations to me, the Secretary, and NOT to any other office or officer. Such mis-direction of requests for change in address only causes and results in unnecessary delay to effecting such requests for address changes. Your co-operation is graciously solicited.

The total membership of record as of the Secretary's report dated September 1, 1968, is 1,048. This figure compares to the total

of 1,027 reported last year; an increase in total membership of 21 over last year.

It is of course very satisfying to again note an increase in total membership. It is also very gratifying to note in the later report on membership recruiting that 45 members participated in new member recruiting this year compared to 37 last year; evidence of increased interest and effort of members to encourage enrollment of their collector-friends. It will be noticed in the preceding that losses from resignations and dropping action are equal in amount this year and last and that the net increase in total membership resulted from 8 less deceased and only 1 the difference in new members enrolled and replaced on rolls. Your Secretary must remark that every effort is made to retain members who tender resignation or are subject to the dropping action for non-payment of dues.

Each year, the "President's Certificate" is awarded to the member who proposed and enrolled the most new members during the year. From January 1967 to December 1967, new members were enrolled by the following members in the numbers indicated: R. J. Woolley (12); J. Levine (7); C. R. McNeil (4); P. J. Hurst (4); S. S. Jim Culhane was asked to visit Williamsburg, Virginia, as the locale for the 1974 convention.

REPORT OF THE EDITOR

It has been a very distressing year in one respect, yet rewarding in another respect. During 1967, Canada's Centennial year took place and many members responded wonderfully with excellent articles to celebrate Canada's birthday. The Editorial Department was never lacking of material and a good backlog existed throughout the year. Some of the backlog overlapped into 1968 but now it has dropped to zero. Even the columnists have not had the time to give me a backlog of columns.

As usual we produced 10 issues of BNA Topics and the Yearbook.

Your editor being a United States underwriting manager and stockbroker has had a tremendous increase in his work load at his office due to the high volume of securities

transactions in the United States. Long and busy hours have thus decreased the time that can be spent on Topics. Correspondence fell behind owing to the loss of an Editorial Secretary and thus time delays with the magazine were frequent. Delays continue the same but we do have a new secretary.

The advertising and secretary's report are usually received around the 8th of the month before publication. Two weeks or more is spent on typesetting and up to two weeks on proofreading and makeup. One week is spent on page proofing and printing and up to a week regarding binding and mailing. By this time six weeks have gone by and the date is around the 22nd of publication month. Postal delays complicate matters further.

Advertising is now being published after the copy is out of date. Two or three years ago I tried to have the advertising cut off date brought forward from one month before publication to six weeks, but this was turned down. Again, I plead for this six week cut off date.

Your editor submitted his resignation to the Chairman of the Editorial Board but it was turned down on the basis that the quality of the magazine remained relatively the same and if there were going to be time delays, the members would have to bear with it. In short the Editor was told to "get back to work".

The other members of the executive have been very understanding and helped lighten the load when possible.

I do plead for more articles and columns.

REPORT OF THE CHAIRMAN OF THE EDITORIAL BOARD

We had very few problems on the Editorial Board and only one manuscript was returned as unsatisfactory.

The Society is lucky in having such a capable Editor as John Young. Although an extremely busy man, Mr. Young has handled this thankless job with dignity and ability and the Board wishes to thank him for his devotion to BNAPS.

Mr. Young explains the lateness of Topics in his report and I believe this difficulty will shortly be overcome.

REPORT OF THE LIBRARIAN

The Library has continued to make steady progress during the past year. Requests for loan of books and pamphlets come in regularly which indicates that members are becoming more conscious of the B.N.A.P.S. Library and the services which can be supplied.

It will have been noticed that we have made a beginning on the revised listing of items in the Library. As planned the material is being listed by subject and is being published in "Topics" as it is prepared. Indications are that this new list is drawing additional requests from members. This program will be pursued with a maximum of effort until it is completed. Some of the items which were being published such as reviews of older publications have been suspended in favour of our revised list which, at the present time is felt to be of greater importance.

The book-plates which were announced at the 1967 Convention have been prepared and are being used on all new books and on all volumes which we have had bound.

Donations of material to the Library have been quite extensive during the past year. New material is being incorporated into the card-index file as rapidly as possible but a large quantity is still to be done. Donations of cash to cover the cost of new material and for book-binding have reached a total of approximately \$175.00 and this is enabling us to advance this work very

rapidly. About 25 volumes have already been bound or are at present being done.

You will have learned from the Chairman of the Board of Governors that the Library has been the recipient of a grant from Mrs. C. M. Jephcott and this will be used to further the development of the Library and provide a fitting tribute to a great student of B.N.A. philately.

It is now three years since I had the honour of taking over the position of Librarian of this Society. During this time I have made many friends among the members who write to me for material and information. I hope I have been successful in helping them and that more members will take advantage of the facilities of our Library.

REPORT OF THE SALES MANAGER

Sales Manager Jim Lehr reported to the meeting that sales in the department were over \$6,000 last year. The year started with over 300 books in the circuits for distribution but, he had only slightly over 100 books at present. The need for new and additional books for distribution by the department was very dire and critical and, unless such were forthcoming, it was inevitable that the circuits would be exhausted. He asked that the Board of Governors consider a ruling that would require that members, when purchasing from a circuit, indicate and certify such purchase with their membership number entered in the space of purchase rather and in lieu of the name. It would simplify and expedite identification by use of a membership number for identification.

Mr. Lehr moved the acceptance of his report and, on second by John Young, it was accepted.

REPORT OF THE HANDBOOK COMMITTEE

Handbook sales continue to be an active department of our Society and as these sales contribute considerably to the income of BNAPS the committee would like to suggest that you purchase your reference handbooks from our sales department whose list of available titles you will find in each issue of Topics.

Since our last convention there has been a 1968 edition of the Canada Precancel Catalogue edited by H. G. Walburn, BNAPS

No. 243, The History of the Canadian Railway Post Offices by L. F. Gillam, editor of Maples Leaves, CPS of GB, and the eleventh edition of the Holmes Specialized catalogue with price revisions by a committee of your Society. All these have been handled by your handbook sales department and have had good acceptance.

A summary of sales and stocks on hand follows. It should be noted that between 75% and 80% of sales are at wholesale prices to stores and dealers and the committee appreciate their co-operation which makes it possible for us and other Societies to publish this reference material:

BNAPEX '68 at Texas

The silver jubilee convention of the British North America Philatelic Society swept into the deep south for the first time, meeting in Austin, capital of Texas. It provided members with the facilities of Lake-way Inn and Marina, an air-conditioned resort 15 miles north on Lake Travis in the picturesque hill country. This included all kinds of athletic and sport facilities for recreation.

By consensus of philatelic experts, this was the finest exhibit of Canada ever assembled. Exhibits ranged from pre-Confederation days to modern times in all categories, including pence and decimal issues from prize winning collections. Each class was restricted to a single frame of eight album pages and 135 frames were on display.

Stamps and covers of the early provinces, airmails, postage due, revenues, military and patriotic were all there along with much related material seldom seen to such excellence. Fabulous was a word frequently heard from philatelists viewing the show which was not open to the public.

Seminars by 13 study groups featured the convention and were well attended.

A bourse had five tables for dealers: C. F. Horton, Los Angeles; Ray Peters, Phoenix (with son John and his wife Donnell); Fred Jarrett, George Wegg and Stan Lum, all of Toronto. Biggest sale was covers.

A reference library of outstanding texts was set up by Librarian S. S. Kenyon, available for daily reference.

Ed. A. Richardson and his wife Mickey of League City, Texas, were hosts and organizers of the convention and show. Mrs. Jo Ann McCann, executive secretary to Ed, gave of her holidays to serve the registration.

ENTERTAINMENT

The Inn having been booked for the whole week, there were a number of early arrivals. On the Sunday previous a number visited Hemisfair, on the closing day of the World's Fair in San Antonio. On Monday and Tuesday there were drives. Festivities opened with an outdoor barbecue at the lakeside cottage of the hosts on Lake Travis.

On the opening day there was a 40-mile drive through the scenic wooded hill country past cattle ranches to a cocktail party at the host's cottage. Friday saw a bus tour of historic San Antonio for 50.

Sailing and horseback riding saw some of the younger members such as Jephcott and Young.

LIGHTER MOMENTS

White cowboy hats were presented to two stalwarts when they were publicly initiated in the BNAPS Fun Society, "Order of the Three Beavers," recently founded by Clarence Westhaver and Ed Richardson. The pair of high-hatters were veteran Jack Levine and pioneer Fred Jarrett, recently 80.

There was a bit of fun when a birthday cake, topped by candles, was presented to Al Cook with song accompaniments.

Reception line for the Past Presidents' dinner comprised Vinnie Greene, Ed Richardson and Mickey, Harry Lussey, Mr. and Mrs. G. B. Llwellyn and Mr. and Mrs. Clarence Westhaver.

J. S. Siverts, chairman of the elections committee, sent a report of 189 votes of which 183 were good. Results:

President, Dr. Robert V. C. Carr, Youngstown, Ohio; vice-president, Sam C. Nickle, Calgary; secretary, Jack Levine; treasurer, James T. Culhane; board of governors' trio for 1969, 1970, 1971, Alfred P. Cook, G. B. Llwellyn, and C. Russell McNeil. Dr. Carr's elevation having left a vacancy on the board, this was filled by the board naming Dan Rosenblat of San Francisco to complete the unexpired term, in the 1968-70 trio.

The Edmonton BNAPS regional study group arranged for color flash portraits to be made of all members attending the convention and of all ladies attending the closing banquet. These slides may be borrowed by other units upon application to the Edmonton Regional group secretary.

Various handbooks of the society were available for purchase at the registration desk.

Dr. Ian Taylor's "Stampography"—an arrangement of bits of U.S. stamps worked in designs of maps and animals—was on display in the exhibition hall. It found favor among non-collector ladies.

The show was staged in glass frames as pairs, linked on tables.

Clarence Westhaver as co-ordinator did a splendid job conducting the 13 specialty study seminars where a total attendance of 165 was noted.

Available reference material received a great boost in a gift from the hosts. Ed Richardson was the author and publisher of ten new texts. All these monographs specially prepared for BNAPS' Silver Jubilee meeting in Texas, were principally selections from his regular column, "Hollow Tree" which originally appeared in *Popular Stamps* and continues in the *Canadian Philatelist*.

The 1,300 pages were typed by Mickey, reproduced with illustrations by Xerox, and bound in colored card covers, 50 copies of each.

Each seminar participant received a copy and the surplus donated to the Handbook Department of the society for sale at \$1.50 for each monograph. No more complete sets are available.

Titles of the ten monographs (abbreviated): *Interrupted Mail*, *Airmail Sidelines*, *Military Mail Part One and Part Two*, *Postal Stationery*, *BNA Revenues*, *Express Labels*, *Postal Booklets*, *Patriotics*, and *Phantoms*.

Previously published texts available from the Handbooks section included: *The Admirals*, *Registered Letters*, *Precancels*, *Squared Circles*.

Each seminar was conducted by chairman from the specialty concerned with this resulting roll of conveners and attendance: *Patriotics*, Clarence Westhaver, six; *Express Labels*, no meeting; *Airmails*, Dan Rosenblat, nine; *Military Mail*, Sam Nickle, nine; *Revenues*, Wilmer Rockett, 14; *Booklets*, Al Cook, 19; *Admirals*, Harry Lussey, 19; *Interrupted Mails*, Ed Richardson, 20;

Squared Circles, Dr. William Moffatt, 17; *Phantom Philately*, Richardson, 19; *Territorials*, S. S. Kenyon, 22; *Postal Stationery*, Marks Arons, five; *Precancels*, R. J. Woolley and H. G. Walburn, six.

In view of the fine texts available, no attempt to summarize talks. A few notes about supplementary material are offered.

Sam Nickle in leading the seminar on *Military Mail* said that numerous items exhibited in this show among *Patriotics* and *Stationery* could equally well have been used in a *Military* class. He pointed to the benefits in supplementary reading such as *Canadian Soldiers* by Lord Stanley, now out of print but available in the society library.

GOOD ANYWHERE

Dealing with *Interrupted Mail*, the monograph on which contained illustrations of letters "salved from the sea, recovered from train wrecks, and singed in plane wrecks, Ed Richardson said such a collection could be displayed and win appreciation from any audience.

Dan Rosenblat, talking on *Airmails*, remarked that "good literature helped make and maintain philately."

Harry Lussey, leading discussion on *Admirals*, said that George Marler had done a tremendous job with his early brochure but there is need of a new publication to cover recent studies, and it should add *precancels*.

Speaking of *Phantom Philately*, Ed Richardson said Allen Taylor made 80 per cent of Canadian fakes. Of so-called *Canadian Locals*, only two were correctly placed in that class, *Columbia River Locals*, *Cariboo Express*.

Convener Westhaver reported that many fine stamps that had been donated to general museums were being destroyed. Steady display under strong lights by non-philatelic directors was bleaching delicate colors.

He made a plea to all collectors that their aim should be in case of a change in collecting interests or death, "get the stamps back in collectors' hands." An allowance on succession duties is gained by giving to a museum but such a destination was not good for the hobby.

Having spent two days at the show, Dan Rosenblat flew home Friday night to attend his daughter's wedding in San Francisco Saturday.

Ed had issued a printed program which listed all exhibits. He said that 37 members submitted exhibits. A glance shows

several sent seven but Ed supported the exhibition with 17.

There was a good attendance at the BNAPS annual meeting on Saturday, October 12 in the Vista Room. President Bob Woolley presided, making a brief report and said he had received the greatest of co-operation which made his second and final year pleasant despite publishing handicaps.

Bert Llewellyn, chairman of the board of governors, said that during the year two complaints were lodged by members; the parties were notified and settlements promptly made.

Isobel Jephcott, widow of Dr. Clare Jephcott, donated \$2,500 to the library, suggesting that a trust fund be established, annual revenue being used for improvements. This has been done and the membership has expressed its appreciation.

Jim Culhane made the treasurer's report showing an estimated deficit of \$288, compared with an estimate of \$383 made a year ago.

Secretary Jack Levine said it gave him extreme pleasure to attend personally after two years of absence.

He reported an increase of 21 members to 1,048. A. Graham Fairbanks of Westmount won the Greene award for articles in Topics but had been unable to attend to receive the trophy personally.

DATES ARE SET

The society looks far ahead on convention plans, even six to eight years. Chairman Ray Peters recommended acceptance of an offer for 1969—approved. It will be in the Bayshore Inn, Vancouver, October 1 to 4 with a committee already at work, Jim Pike, Jack Wallace and Bill Topping, chairman.

It was reported that the Royal Philatelic Society of Canada will soon swing back to spring dates and any possible clash in plans avoided.

Tentative lineup: 1970—Baltimore; 1971—Halifax; 1972—Los Angeles; 1973—Calgary, immediately after the Stampede in Calgary Inn; 1974—Williamsburg; 1975 or 1976—Philadelphia.

Year 1976 is the bicentennial of the Declaration of Independence and celebration plans include a world stamp show. Aim of the American organizers is "finest international stamp exhibition ever." There is some doubt as to feasibility and desirability of meeting then.

Membership convener Al Kessler was unable to attend. President Bob reported an exchange of advertising space with sister journals was being devoted to promotion, also space in the yearbook.

CHANGE AT TOPICS

Topics Editor John H. M. Young reported that during Centennial Year many members had contributed special articles to make it a fine one. But numerous difficulties plagued publication this year such as the postal strike, printing delays and slow mails. His own line, the brokerage business, had pressed heavily with overtime, making it hard to devote time to TOPICS. It had become necessary to replace the editor.

"It was very distressing but rewarding," he said. As a result he had resigned here but the board refused to accept it, and he had been told, "Go back to work," he added.

In the dying hours of the convention, there was a second thought on his part, and Mr. Young withdrew from the position of editor.

Mr. Young had again put in a plea to extend the closing time for receipt of advertising from the present four weeks prior to publication date to six, and his suggestion goes to the board.

V. G. Greene, chairman of the library board, said that the Jephcott donation was greatly appreciated.

Also chairman of the editorial board, Vinnie reported few editorial problems encountered, one manuscript being returned as unacceptable.

LIBRARY PROGRESS

S. S. Kenyon, Librarian, reported that the library continued to make progress as the membership became more aware of its resources. Donations of material continue to be quite extensive and book plates are used on donated books. The sum of \$175 has been given to the binding fund. The program of revised listing proceeds. He lauded the Jephcott gift.

Advertising Manager Ed Whiting said that the late publishing of Topics with the ads sometimes appearing after the events, was a problem. He had received the greatest cooperation from the editor even when copy was late. Over the year seven to nine pages of advertising held at a fairly constant level. His crash drive for booster ads in the yearbook brought a disappointing response, around 10 per cent of the membership participating.

CIRCUIT FADING

Jim Lehr, sales manager, reported he had received 325 circuit books from Al Cook, but because members were failing to replenish the supply, the total books in circulation had dropped to 135. Even with this sales to date amounted to about \$5,000 and he expects they would reach \$6,000 for the year, with a profit of around \$1,000.

He doubted whether the society will be able to keep up a sufficient supply to maintain the circuit. Two members had resigned because of the failing circuit. He urged members to use a rubber stamp showing their membership instead of pencilled initials.

Jim Sissons, chairman of the board of examiners, said that no stamps had been submitted during the year.

Ed Richardson had served as chairman of the Handbook Committee and none had been published during the past 12 months. Condensation of Trail of Caribou articles by Dan Myerson under the chairmanship of Bob Pratt was a difficult task. Retail sales dropped to 109 handbooks while wholesale business amounted to 593 copies.

Winner of the President's award for membership recruiting was President Woolley.

Circulation Manager C. Russell McNeil reported having secured a better quality paper for the printing of Topics.

Your publicity director reported dispatch of advance publicity prior to conventions and the sending of after show stories. (There has gone into the mails since BNAPEX '68 150 Xerox copies to philatelic journals, writers, leading U.S. and all Canadian dailies.)

The president reported that he had headed a committee working in behalf of the society in revising the 11th edition of Holmes Specialized Catalogue of Canada and British North America. These members served: L. A. Davenport, V. G. Greene, F. Jarrett, R. N. Pratt, E. A. Richardson and J. F. Webb.

Dissatisfaction having been expressed about late delivery of ballots enclosed with Topics, and consequent late arrivals of votes, a message from Chairman John Siverts reassured members that late votes could not have changed results in the election.

Dr. Ian Taylor who attended the convention last season of the Canadian Philatelic Society of Great Britain, publishers of Maple Leaves, brought greetings from Eastbourne.

SLOW MAILS ANNOY

Extremely poor service given third class mail, especially south of the border where copies of Topics reach members six weeks after being mailed in Toronto sent first class on publication day to officers of the society.

Many suggestions were made such as mailing first class, reducing the number of issues from 12 to six; (the Royal issues six) ballots by letter. Fears were expressed about the new high postal rates. In Canada delivery of Topics usually consumes two weeks. It was said that first class mail would be extremely costly and might call for higher fees.

David Verity provided the link with the Canadian and U.S. post offices—he has the delivery delays under investigation.

Printing complications and greatly delayed schedules at Toronto right after the postal strike. Motions about a remedy were offered but turned back with the complex problem going to the board, including the deficit-plagued yearbook publication.

ANNUAL BANQUET

There was a full attendance at the annual banquet in the Vista Room. President Woolley presided, and after congratulating Ed and Mickey on "A marvelous convention," turned over proceedings to the co-chairmen.

Specially engraved Certificates of Honor were presented by Ed Richardson to all exhibitors of single frames, along with a silver Olympic medal from Mexico. Printed on the fine leather case were the words, BNAPEX 68 Silver Jubilee Award. Everyone present received an Olympic medal with the leather case inscribed Silver Anniversary 43 BNAPS 68.

To those who supplied numerous frames he had a special award, a bon bon bowl in Revere silver.

Ed made presentation of full gift sets of his topical monographs to the guest of honor, founder Jack Levine, to board chairman Bert and to the library. He had various gifts for several persons who greatly helped make the convention a success.

The membership presented Ed with a brass bell for his cottage, and a large flowering plant to Mickey. On behalf of friends north of the border, a carved Canadian Goose was presented by Sam Nickle.

The upcoming president, Dr. Bob Carr, who takes office January 1 was formally presented to the audience.

INVESTMENT

One frequently hears that stamps are a relatively poor investment as opposed to the stock market, real estate and other means of reasoned speculation.

As in most generalizations, there is an element of truth in this statement. A collector who dabbles in stamps for amusement and periodic relaxation will probably obtain the relative financial return that another person toying with the stock market will get.

The competent philatelist who purchases outstanding items from reliable sources will almost certainly have an excellent long-term investment as well as much pleasure.

All that is necessary is to refer to the auction catalogues of the Ferrari, Hind, Pack, Caspary and Crocker sales. If one checks the big pieces for the prices realized at the time there is no question that philately is competitive with many other areas of informed speculation.
