This was the 86th annual convention sponsored by the Baltimore Philatelic Society and featured a new venue at the BWI Airport Marriott and a new date for this "World Series of Philately" (*WSP*) show. BNAPS was also represented by a recruitment table. Although there were only 9 attendees, the talk by Past President Ron Majors, OTB, (left) entitled "Mail between Canada/British North America and the Confederate States during the US Civil War" was well received by members and some guests. The next Regional Meeting will hopefully be held in the Spring at NAPEX outside of Washington DC.

Second Canadian Military Postal History Anthology now available

BNAPS is pleased to announce the release of the *Second Canadian Military Postal History Anthology*, published by the BNAPS Canadian Military Mail Study Group; Mike Street, Editor/Compiler. The first *Canadian Military Postal History Anthology*, published in 1991, was 250 pages in length. Interest in Canadian Military Mail has continued to be strong enough to result in a <u>second</u> 250 page *Anthology*. The 44 articles, written by 21 authors, cover the period from 1897 to 1997.

There are several Boer War articles, more than a dozen from World War I, a larger number from World War II, plus a few from the Korean War and the post WWII peace keeping era.

Subjects include commemorative covers for Boer War Nurses; postage applied to WWI mail arriving in

Canada from servicemen and women serving in France and Belgium; an explanation of WWII Blackout cancels originating in the United Kingdom; WWII Armed Forces Air Letter rates from India to Canada; and life on a Minesweeper during WWII. Other subjects include a photo of the Canadian Postal Corps Staff taken at Salisbury Base Camp in England in 1915; photographs from the transit of the Czech Legion

across Canada after World War I; and mail to and from Royal Canadian Navy personnel

during World War II. The 1997 article concerns mail handling for Armed Forces

personnel helping out during the devastating floods on the Red River near Winnipeg that year.

Jersey is a fascinating island to visit. On the tours of the island we saw the Lalique chapel, a 13th-century Church, the remains of World War II German defense structures and a hospital the Germans built deep into a mountain in anticipation of many casualties when the Allies landed to regain the island. It turned out the Allies bypassed the island and simply waited for the Germans to surrender.

But, for your editor, perhaps the item of most interest was one of the many mailboxes scattered about the island. They date from the time of Victoria (I was on the wrong side of the bus as we passed it).

These mailboxes are now sealed and no longer in use, but they serve as a reminder of the postal history of the island. The box illustrated to the left is from the reign of George (I couldn't tell whether V or VI). At one point, the post office wanted to remove these boxes, but the community rose up and insisted they stay. And so here they are. I'm sorry I couldn't see more of these boxes, but I was able to buy the stamps Jersey issued

Miscellaneous Comments on Canadian Revenue Stamps

The twenty-six items summarised below are discussed in greater detail in a number of articles published in Canadian Revenue Newsletter (CRN), as cited at the end of each section.

1 - Provisional War Tax Overprints on Postage Stamps - No Post Office Connection

In the eyes of senior Postal Officials at Ottawa, the 5-, 20-, and 50-cent postage stamps overprinted "War Tax" were never valid for postage as they were no longer stamps of the Post Office Department. However, a poorly worded circular of 16 April 1915 opened the possibility for their postal use at the local level. This miscommunication was corrected by a circular of 20 May 1915. The Post Office played no part in the production or distribution of these provisionals. Their existence came as a complete surprise to the Deputy Postmaster General (the highest-ranking civil servant in the Department), and upon learning of them he immediately protested to the Postmaster General the appropriation of postage stamps by the Inland Revenue Department. 2 - War Tax Stamps - Not Issued to Finance the War - Public Knowledge in 1915

The War Tax stamps of 1915 were NOT issued to finance the war effort. The government's policy at the time was to finance World War I (then known by variations of "Great European War") through borrowing. The money raised from Inland Revenue War Tax stamps (and other War Taxes) was intended to replace the Customs duties lost due to the wartime reduction in trade, and was used for general administrative purposes. The Postal "War Tax" stamps were postage stamps, and funded the operations of the Post Office, whose deficit would otherwise be financed out of general revenues. The various stamp and non stamp levies were taxes because of the War, not taxes for the War. (See *CRN* № 71 & 92)

As discussed in *CRN* № 118, the true status of the stamps was public knowledge in 1915. The situation was publicised in newspapers at the time of the federal budget of 11 February 1915. It is later philatelists who incorrectly interpreted the inscription of "War Tax" on the stamps as meaning taxes for the War. Some contemporary headlines of 12 February 1915 are given below:
