The Retail Purchase Tax imposed in 1942 by the Federal Government. It was a form of Excise Tax added to the retail price of the article at the time of purchase. The purchaser paid the tax to the vendor, who in turn paid it to the Government. This tax was in a ddition to the Federal Sales Tax which was collected and paid by the manufacturer or wholesaler at the time of the sale to the retailer.

The Retail Purchase Tax, imposed by the Federal Government was an additional tax and distinct from the Provincial Sales
Tax, also collected by the retailer at the time of sale.

When the Federal Retail Purchase Tax was imposed, Quebec (and Maybe New Brunswick) were the only provinces imposing a provincial sales tax.

Now (1983) all provinces except Alberta have a provincial sales tax at the retail level.

As the Retail Purchase Tax applied to Jewellery, precious stones, watches and similar items it was commonly known as the "LuKury" Tax. The retailer was obliged to keep a record of all sales, and either on a duplicate sales slip or on a recap, affix excise stamps for the amount of the tax.

Stamps in various denominations would be purchased from the Collector of Customs and Excise. Periodically an auditor would visit the retailer. He would check the sales record and cancel the stamps, Where the retailer had failed to charge tax on any item that was deemed to taxable, he would be assessed and have to pay the tax himself. The sales vouchers had to be stamped on a daily basis. Since the retailer would not go to the collector daily to purchase stamps he was obliged (OVCH)

to have sufficent stamps on hand to cover current sales.

Some larger department stores could apply and be permitted to submit a return and pay tax on a monthly basis, rather than purchase stamps to affix to daily sales records. However, this was not a common practice.

The rate of the Retail Purchase Tax was 25% of the retail price. The Retail Purchase Tax, as such, was repealed in 1949. However, an excise Tax of 25% still applies on certain luxury items. But it is based at the manufacturer's or wholesaler's level and paid by means of declarations or returns.
