This issue is a bit later than planned. We took several days en route home from BNAPEX '95 and there was a pile of things waiting which had to be cleaned up first. The Sept.-Oct. issue will be mailed on schedule.

As we embark on our fourth year we are pleased to report membership and advertising rates remain unchanged. Prices for a complete set of Vol. I, II, or III are now US\$ 11.00 each. This is an increase of \$1 reflecting increases in paper, copying and postage costs.

During the past six weeks we covered a bit more than 4300 miles. One of our most enjoyable stops was a visit with John and Susan Jamieson and their staff (Saskatoon Stamp Centre). John has a vast reference file covering a wide spectrum of Canadian material and especially material he has handled dating back to when he first entered the Philatelic business. If only there were a simple way to digest and compact this treasure for publication! As John says, "If I could only win one of those big lotteries."

Welcome to our newest member: Robert G. Footitt, RR#2 - Klondike Rd., North Gower, Ontario, Canada KOA 2T0. Bob collects Elizabethan period Commemoratives and Definitives 1953 - 1963 ; Classical period definitives (Karsh, Wilding and Cameo) and postal markings, First Day Covers and town cancels 1953-63 of all types, primarily western provinces. If any of you are over stocked in any of these areas I am sure Bob would enjoy hearing from you.

BNAPEX '95 was put on by Edmonton and Calgary BNAPS members and the Edmonton Stamp Club. Overall it was an excellent show. The Bourse was fully subscribed with 25 dealers plus BNAPS Book and Circuit Departments. There were over 140 competitive frames (using ESC's new AMERIPEX style 16 page frames) plus 11 Study Group

Displays and, in a separate room, the ESC Regional Show with an additional 40 frames of exhibits. A future BNAPS publication will cover the show in some depth. If there is a complaint, it would be the lack of stamps in the frames. With a few exceptions most of the frames were filled with covers. Based on Peoples Choice voting the Study Group entry fees were returned to the four most popular displays. As a result the Elizabethan Study Group entry fee was returned.

The title page from the ESG Display is shown on page 4 and the display will also be shown at Apple Harvest '95 in Spokane, WA on Sept. 23-25 and at the Peach State Stamp Show in Duluth, Georgia on Oct. 28-29. By restricting the material to that owned by the Editor the Display may be included in the qualifying frame count of any WSP level show even though entered non-competitively.

There were 16 attending the Study Group meeting. Included were Harry Voss, Jack Schmidt, George Smalley, Rick Penko, John Hillmer and Robert Haslewood. Ritch Toop was to be our main speaker but is very ill and was unable to attend the convention. I am sure he would appreciate a card from his many friends. (See roster for address). We did have a good round table discussion on several topics of mutual interest.

John Hillmer, Rick Penko and I had a good session regarding the status and future plans for the variety reporting program. There is a bit of further work required as well as a sounding with the membership. You will see more on this in coming issues.

Bill McCann's new booklet catalog which was turned over to UNITRADE for publication several months ago is still on hold. Evidently Unitrade resources are devoted to bringing out a new basic beginners catalog for stamp collectors and those using preprinted commercial albums. Ads for the catalog are now appearing in Canadian Stamp News. Several of us have written one liners to UNITRADE expressing the hope McCann's booklet catalogue will be available by Xmas. There are two significant changes in the Canadian Auction line up:

First, in response to both bidder and consignor requests Ron Leith Auctions have now been expanded to include a major stamp section. Bryan E. Snow from Rocky Point Enterprises is handling all stamp consignments. Bryan brings 40 years of philatelic experience to the auction. Second, Allan L. Steinhart and Bill Longley have announced they are

initiating a joint venture auction program. I believe their first offering is scheduled later this year. Write either for a copy of their first sale.

John Schmidt is out with a substantial revision to his "A SURVEY of RECENT CANADIAN DEFINITIVE STAMPS". While plans were not yet final, Saskatoon Stamp Centre is looking at ways to make the revision available to those who have already purchased the Survey. (If I recall correctly over 200 copies have been sold)!

The National Philatelic Centre released the following notice with the Distribution of the *Canada-Mexico Migratory Wildlife Stamp*.

"There is a typographical error on one of the four Canada-Mexico Migratory Wildlife stamps. On the design featuring the Kingfisher, the letter "F" is missing from the word "Faune".

Our philatelic customers have come to expect a flawless product from us, and Canada Post will still be able to meet these needs by printing a quantity of these stamps with the correct spelling. The error-free stamp will automatically be sent to you according to your current Standing Order requirements."

The Index for Volume III, prepared by Philip Kohl, is enclosed with this issue. I find I am using the Indexes more and more in keeping tract of the material appearing in the Corgi Times. This is a labor of love and we thank you, Phil, for an excellent and very timely job.

ELIZABETHAN MARKET REPORT

F. E. Eaton and Sons' "Rarity Auction" on June 16-17 contained many wonderful and scarce items. Fine material is still sought after and it appears that the market for these items has "stayed the course" and remains popular. For example, two (!) mint NH 1959 5¢ St. Lawrence Seaway inverted centres were offered in this sale. Competition was very strong for lot 963, a single estimated at \$11,000-\$13,000, and selling for \$11,000 (prices include the 10% buyer's premium). Lot 964, which had a slight corner crease, was estimated at \$9,000-\$11,000. It went to a new home for \$8,800. A mint double print of the 1976 8¢ Royal Military College in a pair fetched \$2,640 against a \$4,000-\$5,000 estimate (lot 974). Another nice error offered was found in lot 975, a 1978 "White Queen" (red colour missing). Estimated at \$1,500-\$2,000, it realized \$1,210.

Many imperforate and part imperforate items were found in this sale too. Lot 979, a 1977 12¢ Christmas part imperf left margin block of six sold for \$1,265. It was noted that only twenty blocks are known and it was estimated at \$2,000-\$2,500. A part imperf 1977 12¢ Sailing Ships

block of four was featured in lot 981. It reached \$2,090 against a \$3,000-\$4,000 estimate. Lot 985 contained a 1981 17¢ Varley Portrait imperf pair with an estimated value of \$2,500-\$3,000. It sold for \$1,540. Other imperforate rarities included a stunning imperf sheet of fifty of the 1990 39¢ Canadian Folklore series which was offered in lot 1007. The auctioneers mentioned that only four sheets had been recorded and this intact sheet may now be unique. Estimated at \$15,000-\$25,000, it reached

\$18,700. An imperf block of four of this issue followed in lot 1008 and sold for \$1,485 (\$2,500-\$3,000 estimate). The 1992 Edible Berry definitive series was also represented with a part imperf block of twelve of the 10¢ Kinnikinnick in lot 1009. It was estimated at \$2,000-\$3,000 and sold for \$1,760. A recent 43¢ Flag booklet pane of sixteen with part imperforate margins found a home for \$4,125 despite an estimate of \$6,500 to \$8,000 (lot 1010).

Other items offered included a full pane of fifty of the 1989 76¢ Grizzly Bear definitive with the scarce perforation 13 x 13 (lot 1000). Estimated at \$750-\$1,000, it realized \$770. An imperf margin pair of the 1989 \$2 McAdam Railway Station in lot 1003 (the left stamp with gum crease) sold for \$412.50 against an estimated \$600-\$750. Lot 1014 contained an imperf strip of thirteen of the 42¢ Red Flag coil definitive and it sold for \$495. It had an estimate of \$750-\$1,000. A very scarce double "G" overprint error on the 1963 1¢ Cameo Official in a block of four was sold for \$1,815 although estimated at \$2,500-\$3,000 (lot 1080).

EDITOR'S 5 STAR UNQUALIFIED RECOMMENDATION

Compass Communications, Inc., 321 Centennial St., Winnipeg, MB RN 1P6 Canada is now marketing a totally acid free 8 1/2 X 11 page for mounting philatelic products. The page is 65 pound white board stock and entirely fluorescent free. This means the page may be slid into a "Tuck" Taylor protector with maximum safety and, you may examine the fluorescence of the material mounted on the page without the page lighting up like a Xmas tree.

Furthermore it is an affordable product and quantities will be shipped fully protected. This means the product will arrive in pristine condition including shipments to the United States. Write Compass for a sample and prices. In case you missed it, Compass Communications is Rick Penko.

The current president of Writers Unit #30 is Charles J. Peterson. Mr. Peterson is perhaps the leading judge, certainly in North American, of philatelic literature. The following comments appeared in the President's Message in *The Philatelic Communicator*, Volume 29, Number 2 Whole Number 108, Second Quarter 1995.

Golden Bugspray Awards

Those of you who read *The Philatelic Exhibitor*, journal of the American Association of Philatelic Exhibitors, are undoubtedly familiar with "The Fly," that anonymous creature who awards fly bites to exhibitions and organizers whose behavior has incurred his displeasure, and golden flyswatters to those he feels are deserving of special commendation.

Literature exhibiting is rarely covered in the pages of TPE, and I've yet to see The Fly take any notice of it (functional illiteracy, perhaps?). I like his style, however, and I'm not averse to borrowing a good idea, so I coopted "the Bug" to make a few observations. (Why a bug, you ask, and not a (book)worm? Naive question—it's a printer's bug, of course!)

The Bug is particularly pleased to note that Joseph Monteiro received a Vermeil with Felicitations at Canada's 3rd National Philatelic Literature Exhibition (C3NPLE) for his *Definitives of Canada: The Last Quarter Century, 1967-1994*, as well as a Silver for *Major Canadian Postage Stamp Errors of the Queen Elizabeth II Era* and another Silver for *A Bibliography on Canadian Definitive Postage Stamps*.

The Bug's can of golden bugspray (or Goldbug spray, if you insist on further literary allusions) goes to Mr. Monteiro and also to those exhibitions where this work-in-progress was presented over the past two years. At C2NPLE, an early one-volume version received a Silver and considerable suggestions from the judges; in subsequent months, and with a continuing series of improvements, it went to several other venues, including Colopex, StaMpsHOW '94 and SESCAL, ultimately growing to two packed volumes. In his foreword to the current multi-volume, multi-titled work, Mr. Monteiro particularly notes the detailed and supportive critiques received from those juries, and acknowledges the considerable positive effect this had in his development of the handbook. So kudos to an author/publisher who has taken a good product and made it much, much better by his willingness to accept constructive criticism—and to those shows and their juries for making literature exhibiting work the way it's intended to.

SECTION III - CARICATURE & LANDSCAPE SERIES

In Vol. II, pages 2-1-4 through 2-1-9, the Editor presented one version of inventorying a specialized series of stamps based on the Caricature and Landscape series. Perhaps the most unique feature of the system was it records only items known to exist because the items are in the cataloger's possession.

It is with a great deal of pleasure to now present an alternate system again based on the Caricature and Landscape Series. This system takes an entirely different approach. Reader comments on either method or yet another method are most welcome. Perhaps in the final analysis it is whatever system works for you - the collector.

An Alternate Inventory System by Jean des Rivières

In a previous issue of Gorgi Times, our editor suggested to the members an inventory system based on the material contained in one's collection which provides the collector a quick appreciation of his holdings. My approach differs in the sense that I am listing everything that is known to exist based on my holdings, catalogues, auction catalogues, articles etc.. I am basically creating a very specialized catalogue for a specific issue. In my case, it consists of the Caricatures and Landscapes issues. Currently my listing contains approximately 300 varieties excluding the booklets for which I am preparing a separate listing. An example is shown on table 1.

The inventory of the known or suspected to exist material is fairly simple. I am using the Scott catalogue numbers for the recorded items and no numbers for the ones not listed. The second column involves the paper fluorescence of each item. This is probably the main problem with the system. The paper fluorescence varies from author to author, or is not mentioned by dealers, and, often there is no way of knowing the fluorescence unless I succeed in acquiring the item. As well, regarding certain stamps (i.e. O.O8 coil) I will assume that all varieties can be observed on all three types of paper fluorescence (See table 2). The third column, tagging, is generally simple however, occasionally, a combination of varieties can be observed (i.e. 691 precancel, one bar tag and doubling of the marginal inscription). The fourth column is limited to the plate numbers or PO which stands for post office stock. Column 5 is one of the most important. In this Column one will insert a description of the variety which can include the nature of the flaw or error and the sheet position. Additional information can be added at leisure. The format column summarizes if the item is a block, corner block pair, single etc.. The legends or codes for this column can be defined by the collector. The loc. column stands for location. This answers the question, where is it? Mounted in an album or in a stockbook. The last 2 columns are for noting the dealer and the price which is filled when the item is acquired or the reference of a known existing item.

This alternate system will require revision on a regular basis. It is far from being perfect. However, it will provide the collector with an excellent appreciation of the material needed to complete his collection, and whether or not completion is likely.

SECTION IX - ALL OTHER - POSTAGE DUES

It has been some time since we have visited the "Red" Dues or, if you prefer, the Carmine Dues. For one whose favorite color is red this series offers a bit of challenge and lots of fun. During the recent trip we managed to acquire four nice items - no rarities but all interesting.

First, a "Request to Call Notice" - a card, blank on one side (form # 33-086-089 (1-79) used by the Post Office to serve notice of need for personal delivery. (Special Delivery, Certified or Registered, COD, etc., and in this case Postage Due of 30¢). The 24¢ stamp is from the fourth series, Perf. 12 1/2 X 12 and measures 20mm x 15.75mm while the 1 & 4 cent stamps are from the third series, Perf. 12 and have the same measurement as the fourth series.

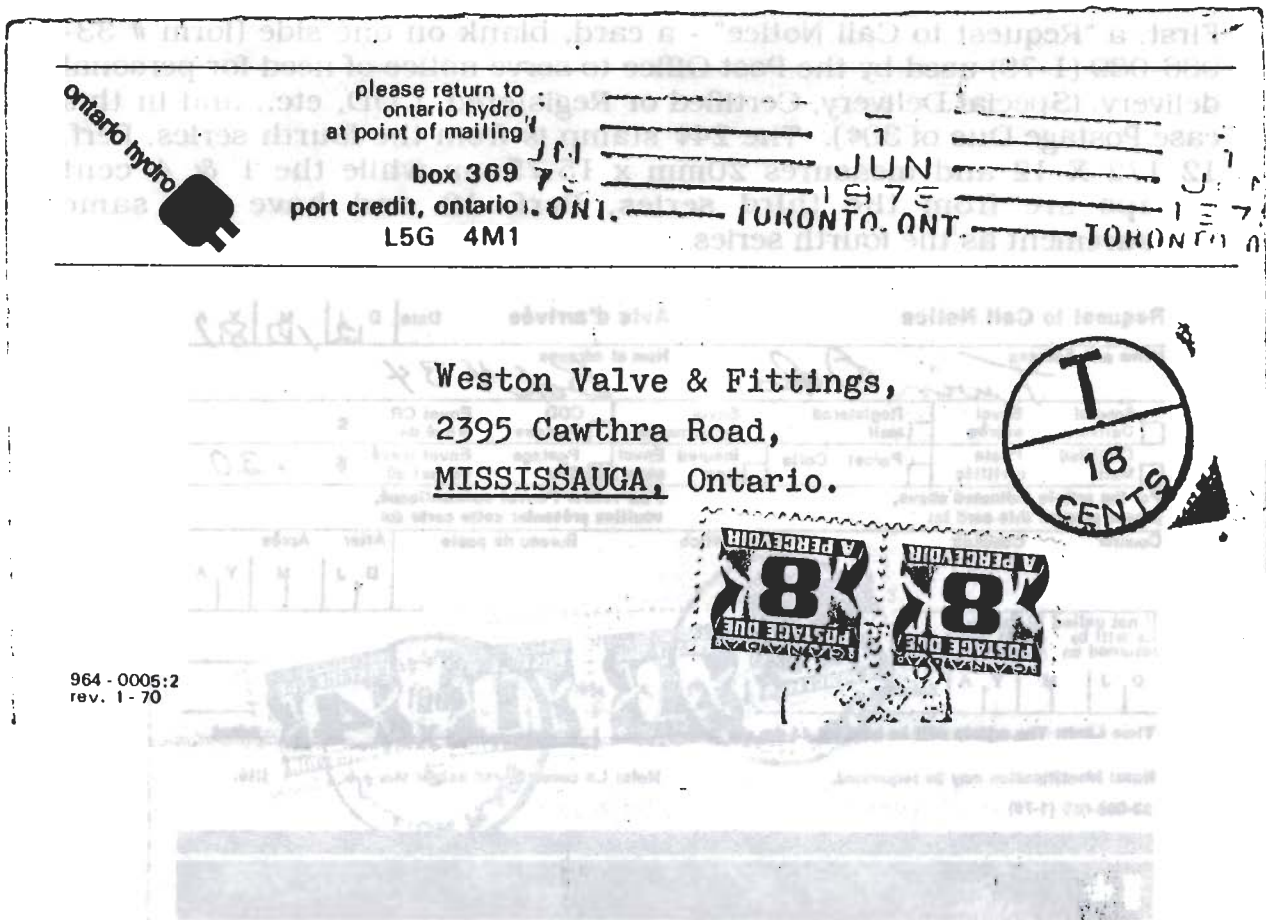

The use of regular definitive stamps for postage due was not authorized. (Evidently the counter clerk and/or the Post Office did not have low value postage due stamps in stock). The postage due stamps are all from the fourth series.

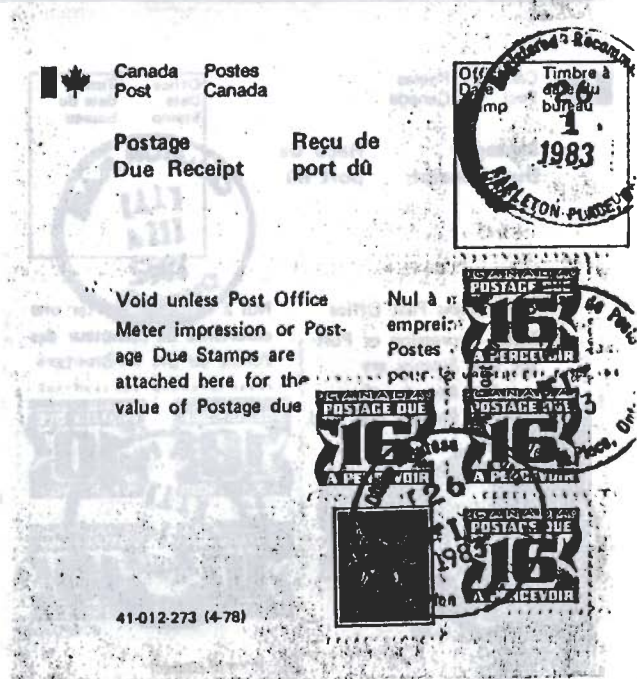
SECTION IX - POSTAGE DUES CONT

Next is a Ontario Hydro corner card with a nice 1 June 1975 Roller Cancel. Mailed without postage, it was assessed 16¢ due (twice the deficiency) and paid by postage due stamps from the third series.



Lastly another Postage Due Receipt form with 67¢ in Postage Due stamps cancelled 26 1 1983. Again, a regular definitive stamp was used for the low value. The Postage Due stamps are all from the third series.

The use of the low value environment series stamps to round out the Postage Due amounts permits using these receipts either with the environment series or with the postage dues.
