THE ONE SHILLING ORANGE ON LAID PAPER:

Scott Standard Postage Stamp Catalogue has this note following Newfoundland No. 10, the one shilling on laid paper:

"The status of No. 10 is uncertain. It exists on

horizontally and vertically laid paper."

It is estimated that only three to six examples of this stamp exist. Last October two of these rare stamps were sold at public auction. One was sold in London on 21 October 1986 as lot number 158 of sale 4485 by Harmers of London. The second was sold in New York on 30 October 1986 as lot number 2143 by Christie's Robson Lowe. The one in London realized \$7,865 US and the one in New York realized \$13,750 US.

Why should the second realize almost twice as much as the first? One only has to look at the descriptions to understand why.
