MORE ON THOSE BOGUS "PARIS" LABELS

A recent letter from David Sessions editor of the Canadian Philatelic Society of Great Britain's MAPLE LEAVES, produced the strip at the right. In the article in Newsletter 36, July/August 1991, it was mentioned that there was a connection with two bogus label from Crete. As can be seen in the vertical strip at the right, the connection is physical as they are printed together. The Crete labels have a character similar to the undenominated boy on a dolphin design reported by Ed Wener.

David Sessions reports that there were five strips each in a different color -- purple, red, blue, brown and green. He also sent along a photocopy of Norman Williams' article from STAMPS & FOREIGN STAMPS of April 1986 on Alfred Baguet, one of the creators of these labels. In it are illustrated two sheets of these labels from the British Library's Campbell Johnson collection. Both sheets are of 12 subjects arranged in two horizontal rows of six. There are no country names or values in the tablets. The four Newfoundland designs are there as well as the two Crete designs. The boy on the dolphin in there in the same relationships with the Newfoundland designs as in the block found by Ed Wener. There are five more designs but the photocopy is to poor to clearly describe the designs. Attempts are being made to obtain clear photographs of these sheets. When they become available they will be reproduced in the Newsletter.

It is most unusual that the strip at the right, the British Library sheets, and the horizontal se-tenant strip pictured on page 176 of Boggs' Newfoundland all come from different plates. One must wonder just what Baguet was playing at,





## 1897 PROVISIONAL EFO



From BNAPSer, John McCrea, comes this oddity. The surcharge has shifted so far that it reads CENT ONE instead of ONE CENT. It is in the type I type face (Scott #75).

The 1897 Provisional was made from a setting of 50, 5 rows by 10 columns. Lot no. 343 in the 18 February 1992 Sissons sale was a complete sheet from this provisional printing. The original sheets of 100 were divided in half and the top selvage was removed to register the surcharge. John's misprint occured when the sheet was properly placed vertically but misplaced either to the left or to the right by half a stamp. Three different type faces were used to make up the complete setting. The top four rows are all type I, short thick serifed letters, (Scott #75), the first eight of the bottom row are type II, tall thin serifed letters, (Scott #76), and the last two, positions 49 and 50, are type III, medium sans serif letters, (Scott #77). This means that there were 35 other type I misprints like John McCrea's. Ιt also means that there were at least seven misprints of the type II surcharge, one of the type III surcharge, and one combination type II - type III surcharge.


#### WANTED
