#### Acknowledgements for Meter Article

New foundland Specialized Catalogue (1992 ed.) Walsh/Butt Metered Mail Articles in BNAPS Topics - Ross W. Irwin Meter Collections of J.D. Wilson & C.F. Rowe LATE FEE

A special collection box in front of the train station in St. John's was cleared thirty minutes before train departures. The contents were placed directly in the mail car. A special fee was required for this late service of two cents. It is not known when this service began and when it ceased. A notice on page 1 of the ST. JOHN'S EVENING TELEGRAM of 28 May 1935 announced this service to the public. This special service is not mentioned in the 1948 Newfoundland Post Office Guide.

This cover from St. John's to New York has the rare "LATE FEE 2c" marking as well as a ST. J. & P.A.B. TPO marking with the date of 25 July 1946. The postage rate to the USA was 5 cents for the first ounce. The handstamp marking in the lower left reads "AUTHORIZED FOR EXPORT BY FOREIGN EXCHANGE CONTROL BOARD."

Clearance on Express Mail Days of Pillar Box in Square at Railway Station

Notice is given that on and from Monday the 3rd June 1935, this box will be cleared specially at 3:30 p.m. on <u>Express Mail Days</u>. All letters deposited in the box after that time for dispatch by the Express must bear a 2c. Postage Stamp for Late Letter fee in addition to stamps for ordinary postage. The box will be cleared finally for connection with the Express at 4:40 p.m. All letters found in the box at that final clearance which do not bear the late fee stamp will be taken to the General Post Office for the next dispatch.

After the last clearing of the Station Letter Box at 4:40 p.m., letters bearing the extra 2c. stamp will be accepted for dispatch at the mail car on the train.

#### LATE LETTER FEE, D.F. 1000


All letters handed to the Mail Clerks on the mail cars or placed in the posting box on these cars must bear late fee postage, i.e., 2 cents in addition to the ordinary appropriate postage.

Any letters which do not dear the late fee postage will be taxed 4 cents to be collected from the addressee at destination.

This notice is from the 1947 Post Office Guide dated May 22. This was the last time this fee was mentioned as C.A. says it is not in the 1948 Postal Guide.

# NEWFOUNDLAND METERED MAIL PART I

### The English Machines

The increased volume of mail being handled by the St. John's General Post Office and its main users, the Water Street merchants, caused problems for both parties in the late 1920's. The St. John's G.P.O. needed new facilities to help them with their problem. The local merchants dilemma could not be solved so easily. Their mailrooms had to be stocked with prepaid stamps of multiple denominations awaiting placement on envelopes. This system was costly, inefficient, and encouraged problems such as pilferage. The use of a company perfin machine solved the problem of pilferage but the inefficient mailroom was not solved until the advent of the meter machine.


### Type I Meter

The Universal Postal Frankers of London, England manufactured the first meter machines used in Newfoundland, their "Midget Type". Although primitive by today's standards, the meter machine would prove to be a labour saving, cost effective and pilferage free device. The "Midget" type meter was issued to three local merchants:

The Avalon Telephone Co. - #1
The Imperial Tobacco Co. - #5
Bowring Brothers Ltd. - #6

The "Midget" type meter was owned outright and serviced by the user. It was capable of issuing three fixed denominations. The circular, local and inland rates of 1, 2 and 3 cents respectively were chosen. The imprint featured the Royal Crown and Cypher while the impression was made in red ink.

The meter Number 1 used both the GVI and GVII impressions. It was the only one to survive Confederation, using a similar Canada Meter until 1953.


### Type II Meter

The second type of meter machine used in Newfoundland also came from London, England, but it was manufactured by Ronco Neopost Co. Ltd. The design for this meter was taken from the one cent value of the 1921 Pictorial Issue, which featured Twin Hills, Tors Cove. It was also a limited value postage meter, owned outright by the user. The fixed values primarily used were 1, 2, 3, 4, 5, 10 and 20 cents. The town name could be set not to print, which allowed combination values to be used. Limited maintenance was provided by the manufacturer. The impressions in red, are usually smudgy and unclear. Clear impressions demand and increased premium charge. The meter numbers allotted to the user companies were 2-4 and 7-32, with number 10 being unknown to date. A few numbers in this series are known to be used by two different companies. The following companies, in 1949, had their machine transferred to a Canada meter with the same numbers:

- # 8 Colonial Cordage Co.
- # 9 Job Stores Ltd.
- #13 Geo. Neal Ltd.
- #14 St. John's Municipal Council
- #28 Harvey & Co.
- #30 Royal Stores Ltd.
- #32 Steers Ltd.


The type I and II meters had the capability for company advertising. Many of the companies used this convenience to advertise their products. The most prolific users were, Avalon Telephone Co., J.M. Winter and the Imperial Tobacco Co.

Newfoundland metered mail types I and II with clear indicia are hard enough to find, but with the addition of advertising, they are almost impossible.


