BOSCH FINDS A MORE EXTENSIVE VERSION!!

In the Sept. - Oct. '85 issue [Vol. 4, No. 5, Whole No. 20, p.32,33] I presented a spectacular Misplaced Entry on the 1¢ Numeral that Warren Bosch [not to mention the one in the last issue!]. Well, this man just NEVER gives up, because now he has found another copy of this same stamp, only THIS one shows a continuation of the entry right across the stamp!!

The original find showed lines only over as far as the right edge of the necklace [below the Queen's earring and directly above the 'C' of CENTS - see photos in above issue]. Warren's new find shows a great many lines [mostly framelines] extending through the necklace on the left, right across the portrait band and into the spandrel lines on the left. There is no trace of these lines on the original copy - I know, I have it!

I find it odd that these lines would wear off the plate first, leaving those on the right just as clear. They could not have been burnished or retouched to remove them, or the lines on the right would have been removed Another quandary!!!

Everyone's HEARD of this re-entry --- it's been listed in all the catalogues for years, even Lyman's --- but some of you may not have actually SEEN it! So here it is!

On close examination, there is much more doubled than just the right side of the portrait medallion: the 'D' of NEWFOUNDLAND; the '7' of 1937; extensions of the horizontal lines of the portrait background into the portrait oval; the trunk of the tree to the right of the medallion; and quite prominently the large numeral '7' in the L.R. corner!



This re-entry is not to be confused with a far more minor re-entry that also involves the right side of the medallion, but here the doubling is only slight. This stamp can be recognized by the slight doubling of the inner vertical frame in the U.R. corner.

I also have a third re-entry on this stamp that shows a slight shift to the left [the above two are both to the right] that doubles both inner and outer vertical framelines, the trunk of the tree, and the L.R. '7'.

In his article, "A Second Latent Re-entry of the 2 Cent Small Queen" [TOPICS, May 1956, Vol. 13, No. 5, Whole No. 135, p.103-4], Peter J. Hurst wrote "The 3 Cent Small Queen, incidentally, has at least one latent reentry which, although similarity is of course absent, belong in the same category in a technological sense."

Well, we have a number of Small Queen specialists in our group. Can any of you offer further information on the stamp that Mr. Hurst was referring to? For example, is it one of the already recognized re-entries on the 3¢ [i.e. one of those in Hans' book], or is it one of the many that are unlisted as yet?? I look forward to learning more about this stamp.

A SMALL CORRECTION TO SESSIONS/MILOS AND REICHE

Re-entry collectors interested in the 2¢ KE7 are likely familiar with the 2.5 mm Misplaced Entry that Marler referred to as "the most interesting re-entry of the Edward Issue". [Marler p.123, 125 fig. 2.35 p.124] [It's too bad he never got to see my 5¢ Misplaced 3R79. Ed.]

In any event, this re-entry shows doubling of the lower portion, including the beard, collar, shading lines that extend into the portrait oval [esp. on the left], etc., etc. However, both Reiche, in his Constant Plate Varieties book, and Sessions, in his Milos Canadian Stamp Handbook, give the incorrect plate position of 86 UL 98. This may just be a 'typo' by the printer, but Marler gives the position as 86 UL 93 [i.e. Plate 86, U.L. Pane, Position #93]. Considering Marler's work is based on direct examination of the proof sheets, I would be inclined to believe that his position is correct.

Both books also illustrate the details with a mat, but both show a large, dark patch of colour on the Monarch's cheek as well as markings in the LNB. These details actually belong to a DIFFERENT variety and should NOT appear on these illustrations. They belong to 85 LR 76 [Marler p.122, fig. 2.33 p.120]. You may wish to note these corrections in your copies of these works.

Incidentally, I'm still looking for the 86 UL 93 Misplaced Entry, in case anyone has a copy they would like to sell or trade.




Among the plethora of re-entries to be found on this issue are a number that are a little more out-of-the-ordinary than the 'typical' re-entry we are used to finding. These are caused by particularly large shifts of the transfer roll and result in some rather 'exotic' looking re-entries.

Examples of two different stamps are shown here: the first in the upper design, with horizontal lines particularly noticeable in the 'A P' of CANADA POSTAGE; and the second in the L.L. of the design, with many extraneous lines visible in 'TWO C' of TWO CENTS, as well as the white ovals above and below 'O C'. There are also marks in the LNB of the latter.

There are just so many 'regular' re-entries on this issue that it's nice to come across something a little different for a change.

I'd be very happy to see any 'different' re-entries that any members may have found on this or any other stamp.





I have found only one re-entry on the 3¢ Maple Leaves Issue so far and this is it. Note the strong doubling in and around the letters of CANADA, particularly the 'CAN'.

I have 3 copies of this re-entry so far. Unfortunately this photo is of the worst of the three, as the other two were found after my last photo session.
