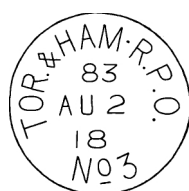

This registered cover addressed to Southampton, Ontario, originated at Boston on May 19, 1919 and entered Canada at Niagara Falls, where it was put on the northbound **ON-607**, TOR. & HAM · R.P.O. / N<sup>o</sup> 3 , 83, MY 19, 19. This is the **first reported use of ON-607**, which was previously only known from the proof strike.




At Hamilton, it was transferred to **ON-203**, TRAIN N<sup>o</sup> / Ham. & S'ampton R.P.O. , PM, MAY 21, 1919. This is only the **second reported use** for this large rubber hammer, now the **ERD** and the first report of the time indicium **PM**.

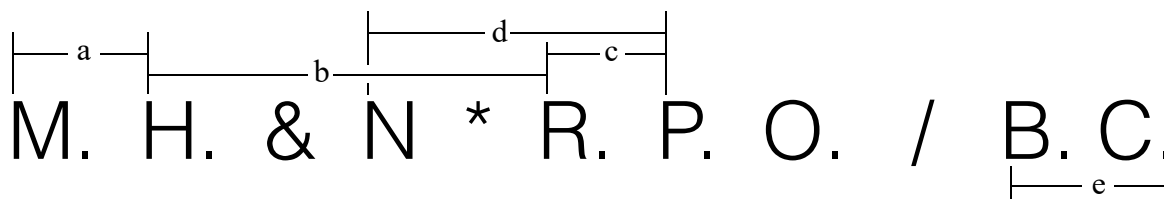

## WT-341 Hammer Study Update

I originally did this hammer study in 2007, using the chordal measurement system of differentiating hammers, with a limited number of examples. After revisiting the study and using the overlay method of identifying hammers, it became apparent that the hammer which I had identified as WT-341.01 from the single proof strike, dated August 3, 1904, was actually hammer WT-341.03. Therefore, hammer WT-341.01 has been removed from the catalogue.

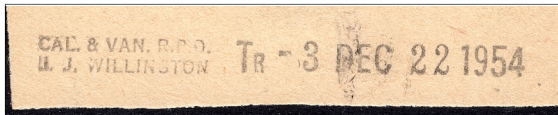

When Simon submitted this example of **WT-315**, LLOYD. & EDM / R.P.O. , 64, JUL 7, 37, as a new ERD, it led me to review the listing data. The Ludlow-Robinson records indicate an ERD of 1937/02/06, which I regarded as an error, since the proof strike is dated 1937/12/30. I have an example in my collection dated 1937/01/29, which I thought probably was erroneously dated, 1937 instead of 1938. With Simon's submission as an additional example of a early 1937 date, I am now inclined to believe that **the proof strike year date is actually 1936/12/30** and that the **correct ERD** for WT-315 is now 1937/01/29.

I considered the possibility of the existence of more than one hammer, but verified that all of the strikes examined were identical using the overlaying method.
